Summary of key findings for parents

The provision meets requirements

- The manager has a clear knowledge of her responsibilities to safeguard children. This includes the procedures to follow should staff be concerned about a child's welfare. She understands the how to carefully recruit and monitor staff to maintain a safe environment for children at all times.
- The manager understands the benefit of reflecting, monitoring and evaluating the quality of the setting, to continually make improvements.
- The manager and staff value the importance of building partnerships with parents and other professionals, to provide consistency in children's experiences.
- The environment is safe, welcoming and includes a range of toys and resources, suitable for children of different ages.
- The manager understands how to support children's well-being. She ensures staff are positive role models and teach children about how to respect one another.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector spoke to the manager to assess her knowledge of meeting the safeguarding and welfare requirements.
- The inspector viewed the premises that are available for children's use and discussed safety arrangements.
- The inspector looked at a sample of documentation and records that the manager plans to use to support children's welfare, and reviewed staff files.
- The inspector held discussions the manager about her systems for self-evaluation.

Busy Bees Mill Hill @ Deanbrook registered in 2014. It operates within Deanbrook Primary Infant School, which is located within the London Borough of Barnet. The club is open each weekday from 3pm until 6pm, during term time only. There are four members of staff, including the owner who holds a relevant qualification at level 3. There were no children on roll in the early years age group at the time of the inspection.
