Summary of key findings for parents

This provision is good

- Staff hold discussions with all parents about their child's previous learning before the time of entry. This helps them to identify what each child already knows and can do. This important information is used well to identify every child's unique starting points from the outset and to build a tailored care and learning plan from the start.
- The staff have developed a strong, shared approach with other providers and professionals. This ensures that there is consistency and continuity for children's care, learning and development.
- All staff demonstrate a high level of care and warmth towards the children. This, and strong key-person procedures, helps children to build strong emotional attachments with those caring for them. Furthermore, children behave well, learn about the rules and develop strong friendships with one another.
- The self-evaluation process helps to identify improvement targets throughout the nursery so that all children benefit from attending the provision. The process includes the views of the management, staff, parents and children. This ensures that outcomes for children continually improve.

It is not yet outstanding because:

■ Staff are not yet successful in making sure that all parents are fully informed about plans for their child's future learning.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

improve the sharing of information so that all parents are consistently informed about the next steps in their child's learning and development.

Inspection activities

- The inspector observed the quality of teaching during activities indoors and outdoors, and assessed the impact this has on children's learning.
- The inspector completed a joint observation with the quality assurance manager for the nursery.
- The inspector held a meeting with the manager and the quality assurance manager. She looked at relevant documentation, such as the self-evaluation and evidence of the suitability of staff working in the nursery.
- The inspector spoke to a selection of the staff during the inspection.
- The inspector spoke to some of the parents during the inspection and took account of their views.

Inspection findings

Effectiveness of the leadership and management is good

The arrangements for safeguarding are effective. All staff attend child protection training. They know what to do and who to contact should they have a concern about a child in their care. All indoor and outdoor areas are checked before the children arrive and throughout the day. This helps to keep children safe. The management provides staff with regular opportunities to discuss their key children and anything else that concerns them. The manager works closely with the company's quality assurance manager. They regularly observe staff and encourage them to reflect on their practice. They seek out training opportunities to keep staff's knowledge fresh and current. This, and good monitoring of the educational programme, makes sure that all children are progressing well across all aspects of their learning and development.

Quality of teaching, learning and assessment is good

Staff encourage older children to explore and investigate the outdoor environment very well. Children take turns to roll balls down pipes as they aim them to land in a large tyre. They repeat this, experimenting as they move the pipes, aiming them at other areas of the garden. Staff skilfully encourage children to use their critical thinking and prediction skills as they consider what may happen next. Staff engage effectively with the younger children, using resources well to promote their enjoyment and fun. Younger children laugh and giggle with their friends as they blow and chase bubbles, trying to burst them. Staff use an ongoing running commentary to encourage younger children's listening and understanding skills during such activities.

Personal development, behaviour and welfare are good

Children are supported to become confident in taking manageable risks in their play. They have a go at climbing and balancing on a range of equipment and keep trying till they succeed. They engage in dance and movement activities, which promotes their overall physical development. Children are provided with healthy snacks every day. This helps them to develop an awareness of a healthy diet and lifestyle. Children play with a range of resources and engage in activities that support their awareness of similarities and differences between themselves and others.

Outcomes for children are good

Children are developing the skills that will support their readiness for school. They use chalks to make marks on the chalk board and talk with staff about their creations. Children use their imagination as they mix concoctions and potions in the mud kitchen. They become engrossed as they imaginatively find and mix natural resources with water, using tools, jugs and other vessels. This helps to excite and motivate children to keep trying. Staff promote children's high levels of self-esteem and sense of belonging to the setting. This positively contributes to their 'can do' attitude to learning. All children, including those in receipt of funding, make good progress in their learning and development.

Stepping Stones (West Street) was registered in 2015. It is one of four settings operated by a private provider. The nursery employs five members of staff. Of these, two hold appropriate early years qualifications at level 3 and two hold level 2. The nursery opens from Monday to Friday all year round. Sessions are from 8am until 6pm. The nursery provides funded early education for two-, three- and four-year-old children.
