# **Summary of key findings for parents**

### The provision meets requirements

- The childminder recognises her responsibility to help protect children's welfare and has all the required policies to underpin safeguarding practice. She has a secure knowledge of how she will report any safeguarding concerns about children.
- The childminder explains how she will teach children to manage their own safety and why this is important. She identifies potential hazards to help minimise risks and the possibility of accidents to children.
- The childminder understands that children need to gain good self-care skills, independence and confidence to be ready for school. She discusses how to teach children to maintain their good health by using effective hygiene routines. The childminder explains the importance of motivating children to learn and developing their self-esteem.
- The childminder recognises that children will benefit by learning to respect any differences, as well as the similarities, between themselves and others. She discusses why it is important for children to learn to observe rules.
- The childminder has a comprehensive knowledge of how she will promote children's learning in readiness for school. She has developed a secure understanding of how to use precise assessments to help identify children's next steps in learning and further their progress.
- The childminder discusses how she will work with parents to promote their children's learning and keep them well informed about this. She understands the importance of parents contributing to assessments of their children's learning from the outset.
- The childminder recognises the importance of reflecting on her professional development needs and acting on these. She intends to seek the views of others to help promote continuous improvement in the quality of provision.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
