Summary of key findings for parents

The provision meets requirements

- The childminder is aware of the need to evaluate her practice and to contribute towards continuous improvement.
- The childminder understands her duty to safeguard children and protect them from harm. She knows how to refer any welfare concerns.
- The childminder knows how to assess children's progress and plan for learning. She understands how to prepare children for the next stage in their learning, including school.
- The childminder understands how to support children's well-being. For example, she plans to provide daily opportunities for children to go outside in the fresh air and to exercise.
- The childminder understands the importance of working in partnership with parents to help provide continuity for children, and to understand children's care needs.
- The childminder understands the need to help children learn to respect one another and to teach them how to behave well.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
