Summary of key findings for parents

The provision meets requirements

- The childminder demonstrates that she understands how to keep children safe and knows the procedures to follow in the event of a child protection concern. She attends regular safeguarding training and is aware of new legislation and guidance that is in place.
- The childminder holds a paediatric first-aid qualification, so that she is able to provide assistance in the event of a minor accident. She demonstrates that she understands the required documentation she should keep to promote children's welfare, including accident and medication records.
- The childminder understands the learning and development requirements, including considering the different ways in which children learn. She understands the requirement to undertake a progress check for children aged between two and three years. The childminder knows how to promote children's learning and carry out effective assessments and planning to meet children's individual needs.
- The childminder understands how to foster children's well-being, safety and good health. She knows how to minimise risks in her home and on outings. She confidently discusses how she would promote suitable hygiene procedures. She understands the benefits of providing healthy foods and spending time in the fresh air.
- Systems are in place for working in partnership with parents to meet children's needs. These include gathering information about starting points and sharing ongoing information about care and learning needs through an online-based daily diary.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector discussed with the childminder how she intends to deliver the educational programmes for children and how she plans to undertake observation, assessment and planning.
- The inspector looked at policies and documents the childminder intends to use when caring for children.
- The inspector viewed areas that are used when caring for children, inside and outdoors.
- The inspector checked evidence of the suitability of the childminder and household members.

The childminder was registered in 2012 and lives in Peterborough, Cambridgeshire. She operates all year round from 8am to 5pm, Monday to Friday, except for bank holidays and family holidays.
