Summary of key findings for parents

The provision meets requirements

- All staff attend safeguarding training and have an understanding of how to keep children safe and who to contact should they have a concern about a child's welfare.
- Staff value the importance of working in partnership with parents and the host school, to complement children's skills and experiences.
- The manager understands the importance of training and self-evaluation in improving provision for all children. For example, she takes into account parents and children's views when considering any changes.
- The manager and staff know how to support children's health and well-being. For example, they provide healthy snacks, including regular outdoor play so that children can exercise.
- The manager is knowledgeable about the requirements for the early years foundation stage. She ensures staff offer appropriate opportunities to extend children's interests.
- Staff know how to support children's positive behaviour and build their confidence and self-esteem.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

- The inspector viewed the areas used by the club and which children access.
- The inspector sampled the club's documentation, including various records.
- The inspector discussed the provider's understanding of meeting the requirements for the early years foundation stage.

Sunnysmiles @ St Marys After School Club registered in 2014. It operates from St Mary's Junior, Infant and Nursery school in Isleworth, in the London Borough of Hounslow. The club opens each weekday from 7.45am to 8.45am and 3.15pm to 6pm, during term time only. The provider employs six staff, of these, five hold relevant qualifications at level 2, level 3 and level 5. At the time of this inspection, there were no children present in the early years age group.
