The provision meets requirements

- The childminder is well qualified. She knows how to actively promote children's learning and development and provide a broad range of interesting play-based activities.
- The childminder understands how to use observations of children's achievements to assess their development and plan for their next steps in learning. She understands the importance of keeping parents well informed about their child's progress to help support children's learning further.
- The childminder has a good understanding of protecting children. She knows the procedures to follow if she has concerns about a child's welfare.
- The childminder has addressed the actions raised at the last inspection. She understands the importance of using self-evaluation and ongoing professional development opportunities, to help monitor her practice and continually develop her skills.
- The childminder understands the importance of teaching children about diversity. She knows how to help children build relationships, encouraging them to consider the needs of others and to share and take turns.
- The childminder demonstrates a good understanding of sharing information with parents about their children's individual care needs and preferences. She clearly knows the importance of promoting children's personal, social and emotional development.
- The childminder gives good regard to teaching children about how to keep safe. She has a clear focus on how to provide daily opportunities for physical activity.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children.
