Summary of key findings for parents

This provision requires improvement. It is not yet good because:

- The childminder does not have a secure knowledge of when to notify Ofsted of changes. She has failed to inform Ofsted about changes to the household or provided required information to enable suitability checks to be completed. This is also a breach of requirements of the Childcare Register.
- The childminder does not display her certificate of registration or make it available to parents on request, as required. This is also a breach of requirements of the Childcare Register.
- The childminder misses opportunities to engage all parents fully in their children's learning at home to support children's development even further.

It has the following strengths

- The childminder effectively monitors children's progress. She swiftly identifies any emerging gaps in development and seeks extra support, if necessary, to help children catch up. Children make good progress from their starting points.
- The childminder has a broad range of resources both indoors and outdoors. She uses space at her provision effectively and uses her good teaching skills to help children learn through play.
- The childminder has very close relationships with children. She knows them very well and understands their developmental needs effectively. Children are confident, settled and make good progress.

What the setting needs to do to improve further

To meet the requirements of the early years foundation stage and the Childcare Register the provider must:

Inspection findings

Effectiveness of the leadership and management requires improvement

Safeguarding is effective. The childminder knows the signs that a child may be at risk and understands the procedures to follow if she has concerns. However, the childminder has failed to inform Ofsted that another adult now lives at the premises, or provide required information to enable checks to be completed. This does not have a significant impact of children's safety, because they are rarely on the premises when children are present and the childminder supervises children well at all times. The childminder does not display or make available to parents her certificate of registration. This does not have an impact on the children's safety, well-being or learning and development. Since the last inspection, the childminder has improved her assessments of children's progress. She has worked with colleagues to develop her skills and make improvements that benefit children.

Quality of teaching, learning and assessment is good

The childminder effectively supports children's learning and development and shares their progress with parents. She uses detailed information from parents and accurate ongoing observations of children to ensure that they make good progress. The childminder ensures that children's personal and emotional development is secure before encouraging them in their mathematical and literacy development. The childminder extends children's learning, such as helping them to count beyond 20 as they bounce on the trampoline. The childminder encourages children to broaden their vocabulary. For example, she chats with them about vehicles moving forwards, backwards, fast and slow. Children have good opportunities to be energetic and extend their physical development. They use the large garden and land behind well, enabling them to use a rope swing and balance on logs.

Personal development, behaviour and welfare are good

Children settle very quickly and understand routines. For example, children know where to get cloths from to help clean outdoor toys that are wet from the rain. The childminder is a good role model for children's behaviour and has high expectations. Children behave very well and are polite. They learn healthy eating habits as, for example, they pick apples and eat them and talk to the childminder about how good fruit is for them.

Outcomes for children are good

Children's development is typical or above average for their age. They enjoy choosing toys and playing independently or with others. They socialise well, show patience and a good ability to take turns. Children follow instructions well and readily ask for help when needed. They learn to manage risks and understand how to keep themselves safe. Children are keen investigative learners who are motivated and ready for their next stages of learning and school.
