Summary of key findings for parents

The provision meets requirements

- The manager and staff understand their responsibility to safeguard children. The manager knows the procedures to follow to ensure suitability when recruiting staff. All staff know what to do if they have concerns about a child's welfare.
- Staff know how to plan a range of activities that build on what children are learning elsewhere. They know how to share information with children's parents and staff at school to find out about children's interests and progress.
- Staff know how to help children stay healthy and safe and how to ensure children enjoy attending. For example, they understand the importance of encouraging children to take part in plenty of physical exercise. They know how to check that the premises are safe. They understand how to teach children the importance of acceptable behaviour.
- The manager knows how to help staff to do a good job, such as providing regular feedback on their performance. She understands the importance of evaluating the provision and planning further improvements.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector discussed with the manager how she plans to meet the requirements of the early years foundation stage.
- The inspector spoke with staff about their understanding of safeguarding, child protection, and first aid.
- The inspector sampled documentation, including staff qualifications and the provider's policies.
- The inspector reviewed the premises and discussed procedures for keeping children safe.

Barn Owls out of school provision registered in 2014 and is located in Weston Turnville Church of England Primary School, Aylesbury, Buckinghamshire. The provision is open from 7.45am to 8.45am and from 3pm to 6pm, Monday to Friday, term time only. The provider employs six members of staff. Of these, five hold relevant childcare qualifications at level 2 or level 3. There were no children on roll in the early years age range at the time of the inspection.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register.
