Summary of key findings for parents

This provision requires improvement. It is not yet good because:

- The childminder does not use her assessments of children's progress to target support more carefully for children whose levels of attainment are lower than other children of their ages. While children make progress in some areas of learning, they are not catching up as quickly in other areas.
- The childminder sometimes does not extend opportunities for children to make more choices about the resources and activities they would like to play with.

It has the following strengths

- Children show that they feel secure and settled with the childminder who builds positive relationships with them and their parents and carers.
- The childminder uses good-quality interactions to support children's learning. She demonstrates and explains new ideas and follows children's interests to engage them in their play.
- The childminder has a good understanding of safeguarding procedures. She supervises children closely and provides a safe environment to reduce the risk of accidents.
- The childminder is a positive role model and teaches children about good behaviour effectively.

What the setting needs to do to improve further

To meet the requirements of the early years foundation stage the provider must:

Inspection findings

Effectiveness of the leadership and management requires improvement

The childminder has made some improvements to her practice since the previous inspection. She now prepares progress checks for two-year-old children to provide the required information for parents. The childminder has developed communication with other settings that children attend to encourage some continuity in their care and learning. However, she does not focus effectively on closing gaps in some children's learning more quickly, to fully prepare them for the next stages in their learning. The childminder welcomes views from parents to inform her self-evaluation and she receives positive feedback. Safeguarding is effective. For example, the childminder keeps up to date with child protection legislation and guidance through relevant training.

Quality of teaching, learning and assessment requires improvement

The childminder reviews children's progress regularly and uses this information to plan activities reflecting their interests. However, she does not plan meticulously for all children to ensure they make good progress in all areas of learning. Nevertheless, the childminder supports children well in some areas. For example, she reads books with expression, helping children to learn new vocabulary and enjoy stories. The childminder encourages children to enjoy music and movement, for example, by joining in with action songs and exploring musical instruments. She engages parents in their children's learning and encourages them to share information from home to develop continuity.

Personal development, behaviour and welfare are good

The childminder gives children good levels of attention and helps them settle quickly. She praises children routinely to develop their self-esteem and confidence. The childminder sets out her expectations for good behaviour clearly to encourage children to cooperate. She teaches children how to keep themselves safe and supports healthy lifestyles effectively. The childminder helps children to learn about their local community and people who are different from themselves. For example, she teaches children about different cultural festivals and takes them on regular outings where they meet new people.

Outcomes for children require improvement

Most children make good progress in preparation for their next stages in learning, although others progress more slowly. Older children generally develop the early literacy and mathematical skills that they need, ready for school. Toddlers enjoy their play and develop new skills and language. They are able to select some toys that appeal to them although other toys are less accessible. Toddlers understand and cooperate with routines, for example, they happily sit in a high chair to eat their snack. They enjoy finding out about the world around them, including animals, people and vehicles.
