Summary of key findings for parents

This provision requires improvement. It is not yet good because:

- The childminder does not effectively risk assess all aspects of her home to help her identify and minimise all possible hazards to children. This is also a breach of the Childcare Register.
- The safeguarding policy has not been updated to ensure that it reflects the guidance of the local safeguarding children board, as required. This is a breach of the Childcare Register.
- The childminder does not make good use of opportunities to extend children's mathematical knowledge and understanding.
- Self-evaluation is not effectively used to monitor all aspects of the childminder's practice and provision. This limits her ability to identify areas to improve and raise outcomes for children further.

It has the following strengths

- The childminder supports children's communication and language skills well. For example, she plans activities that encourage speech and she offers children choice.
- Children are comfortable and happy in the environment. The childminder has close relationships with them, they settle well and are motivated to play and learn.
- Children make good progress. The childminder knows children well and understands how they like to learn. For example, she teaches them skills that will help develop their independence and prepare them for school routines.

What the setting needs to do to improve further

To meet the requirements of the early years foundation stage and the Childcare Register the provider must:

- make effective use of self-evaluation to accurately monitor all aspects of practice, including any breaches of legal requirements.

- The inspector read policies and discussed the childminder's child protection procedures.
- The inspector viewed learning records and discussed children's progress with the childminder.

Inspection findings

Effectiveness of the leadership and management requires improvement

Safeguarding is effective. The childminder has a suitable knowledge of child protection and the procedures to follow to report any concerns about children's safety and welfare. However, she does not effectively reflect on and evaluate her provision. For example, the childminder has not ensured that her safeguarding policy reflects the procedures of her local safeguarding children board. In addition, she does not assess her home and environment effectively to help her identify and minimise all possible risks to children. The childminder seeks the views of parents and children to help her decide on areas to improve. For example, she has altered the layout of her home to provide children with more choice. The childminder has made links with other settings that children attend to help provide continuity in their learning and care. She takes suitable steps to increase her knowledge and skills. For example, the childminder completes independent research, attends mandatory training and shares ideas with other childminders.

Quality of teaching, learning and assessment is good

The childminder establishes accurate starting points when children first start and speaks to parents on a regular basis. She observes children's play and understands how to support and extend their learning. For example, the childminder talks to the children and introduces new descriptive words into the conversations. Children use their good communication and language skills. For example, they ask the childminder for help in reaching toys and recall their knowledge of familiar animals, such as cows and what foods they eat.

Personal development, behaviour and welfare require improvement

The childminder does not fully support children's well-being and safety. Aspects of her home, such as the kitchen, are not effectively risk assessed to identify all possible hazards to children. However, the childminder has secure relationships with the children who are happy and settled in her care. Children behave well and listen to the childminder's instructions when moving around the setting. The childminder provides children with opportunities to learn about other countries and the wider world. For example, they celebrate anniversaries and discuss how others celebrate special events in their lives.

Outcomes for children are good

Children make good progress. They develop their early literacy skills and enjoy talking about wildlife and the world. Children learning English as an additional language quickly develop good communication and language skills. They become confident communicators and learn to interact confidently with other children and adults. Children develop a range of skills which helps to prepare them for the next stage in their learning and their eventual move to school.
