Summary of key findings for parents

The provision meets requirements

- The childminder understands the Early Years Foundation Stage requirements. For example, she knows how to use her policies, procedures and risk assessments to support children's health, safety and well-being.
- The childminder knows what to do if she has a safeguarding concern about a child in her care, including those who may be at risk from extreme behaviours or views. She holds a paediatric first-aid training certificate to support her understanding of what to do in a medical emergency.
- The childminder understands how to evaluate her provision to improve the quality of her practice. For example, she has been proactive in updating her skills through further training and in her partnerships with others.
- The childminder knows how to plan interesting and challenging activities and experiences, to meet children's individual needs and help them make progress. She understands how to support equality and diversity, for example, to help children learn to respect each other.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector spoke to the childminder about how she has updated her skills and knowledge.
- The inspector discussed with the childminder, her plans to improve her practice.
- The inspector sampled the childminder's documentation.
- The inspector assessed the childminder's understanding of the learning and development requirements.
- The inspector observed the childminder's home, her toys and resources. The inspector discussed with the childminder, how she will plan for children's learning and development.

The childminder registered in 2014. She lives in Tilehurst, near Reading, Berkshire. The childminder is available weekdays for most weeks of the year. At the time of the inspection, no children were present in the early years age range.
