Summary of key findings for parents

The provision meets requirements

- The childminder understands her role to safeguard children and protect them from harm. She knows the importance of keeping detailed records of any concerns and the procedures to follow to report these to the appropriate agencies.
- The childminder has a positive attitude to making improvements to the childcare service she offers. She seeks ways to improve her knowledge and skills to help her keep up-to-date with changes in childcare practice.
- The childminder understands the importance of maintaining her paediatric first-aid qualification. She knows how to respond to any minor accidents and emergencies children may have in her home and while on outings.
- The childminder knows how plan a range of activities and use her resources to help children learn. She knows to identify children's starting points and observe the progress they make.
- The childminder understands the importance of working in partnership with parents and other professionals. She recognises the benefits this could have on children's care.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The childminder registered in 2014. She lives in the London Borough of Islington. The childminder works each weekday and operates throughout most of the year. At the time of the inspection, there were no children on roll in early years age range.
