## Summary of key findings for parents

## This provision is outstanding

- The childminder works extremely closely with parents at every stage of the children's attendance. She gathers information about children's current abilities and interests when they first start, and makes close observations of their early achievements.
- Children typically make rapid progress in all areas of learning, particularly in their communication and language skills. The childminder supports children's language development exceptionally well and children speak extremely confidently.
- The childminder checks children's progress in great detail and extremely well. This helps them to make excellent progress in all areas of learning. She knows exactly where each child is in their development.
- The childminder's setting is exceptionally well organised and she provides children with a wealth of stimulating and exciting learning experiences to help them achieve what they need to learn next.
- The childminder continuously reviews her practice and provision to establish what she does well and to identify areas for improvement. She includes the views of parents and children to help inform her highly effective self-evaluation processes.
- Care routines are carried out extremely sensitively and hygienically. This helps to support children's physical well-being.

# **Inspection findings**

## Effectiveness of the leadership and management is outstanding

Safeguarding is effective. The childminder updates her safeguarding training regularly and understands what action to take should she have concerns about a child. Rigorous safety risk assessments support her to ensure a safe and secure environment. She is very effective in identifying areas for improvement, and uses targeted plans and ideas to address them effectively. The childminder shows a strong focus and passionate drive to provide excellent care and inspirational learning for children. For example, she attends training and carries out her own research as part of her ongoing professional development; although, opportunities to enhance her knowledge further, particularly in identifying strategies to support children with specific learning needs, are still ongoing. She shares her knowledge and offers support to parents, so they develop a shared understanding of how children learn best.

## Quality of teaching, learning and assessment is outstanding

The childminder closely reflects on children's play to see how they are learning, and builds on their knowledge and skills immediately. The childminder has strong teaching skills and encourages children to use language at every opportunity. For example, while children explore play dough and engage in role play, she expertly uses questioning skills, which enable children to explore their thoughts and ideas as they respond to her. Children thrive in this welcoming environment and typically have a wealth of learning opportunities to help them succeed. From an early age, children have opportunities to hear and retell stories and to learn about letters to support their early literacy.

#### Personal development, behaviour and welfare are outstanding

Children are extremely well supported by the childminder in being independent and they demonstrate a willingness to do things for themselves before asking for help. Children learn right from wrong and gain an exceptionally good understanding of their community, cultures and the world beyond their immediate locality. The childminder is extremely effective in supporting children's growing understanding of how to keep themselves healthy. For example, children help to grow vegetables. She provides healthy and nutritious meals, which strongly contribute towards their physical well-being and their understanding of healthy lifestyles. Children enjoy a wealth of experiences which enable them to build healthy bodies and learn about the wider world.

#### **Outcomes for children are outstanding**

Children make rapid progress. They develop the essential skills and attitudes for school and their future learning. They play exceptionally well together and build strong friendships. They learn to count and extend their vocabulary through everyday experiences.
