Summary of key findings for parents

This provision is good

- The provider, who manages the club, and staff have worked closely with the local authority adviser to address weaknesses identified at the last inspection. They now promptly identify and remove potential risks in the environment to keep children safe.
- The provider and staff review the good range of activities to ensure that they meet individual children's needs effectively.
- Staff are caring, friendly and know the children well. The key person system works effectively. Staff give individual attention to their key children. Staff support children's emotional well-being successfully and children settle in well.
- Children develop positive relationships between one another and behave well.
- Staff inform parents about their children's interests and how they spend their time at the club.

It is not yet outstanding because:

- The provider and staff do not work closely with school staff to gather information about the children's day at school, to help provide a consistent approach to children's care and complement their learning.
- The provider does not seek feedback from parents to contribute to the evaluation of the club to identify areas for development.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- enhance partnership working with school staff to obtain more information about children's day at school, to help support continuity in children's care and to build on children's interests
- consider different ways to gather feedback from parents about their opinions of the club to enhance self-evaluation and identify areas for development in practice.

Inspection activities

- The inspector had a tour of the areas used for the club with the provider. The inspector walked with, and observed, staff collecting children from school.
- The inspector observed the quality of staff interactions during activities.
- The inspector held a meeting with the provider. She spoke to the staff and children at appropriate times during the inspection.
- The inspector discussed the self-evaluation with the provider and looked at relevant documentation, including the evidence of the suitability checks and training for staff.
- The inspector spoke to parents during the inspection, and took account of their views.

Inspection findings

Effectiveness of the leadership and management is good

The provider ensures that staff use risk assessments and daily checks efficiently to provide a safe environment for children. She reviews practice to plan for further improvements. For example, the provider has taken extra protection measures during school pick-up times to help ensure the security of children. The provider undertakes annual meetings with staff to identify areas for improvement. She assists staff to compete training courses to build on their knowledge and to improve the support for children in their care. For example, recent training has helped staff to gain skills to support children who have additional needs. The provider monitors staff's daily practice and they discuss planning for each child's interests. Arrangements for safeguarding are effective. The provider ensures that staff are alert to possible signs that children may be at risk of harm and know how to refer and record any concerns to protect their welfare.

Quality of teaching, learning and assessment is good

Staff find out about children's interests before they attend the club and use these to help children feel welcome when they first start. Children enjoy choosing from a wide range of different activities. Staff interact with children well. They help children to master physical challenges outdoors. For example, staff encourage children to climb up the wooden frame, to swing and slide. Staff use the large open space well and arrange different ball games, such as football, to develop children's skills. Staff praise children for their achievements and engage them in discussions about their play. Children enjoy constructing different models using blocks. Children are imaginative, for example, they dress up and pretend to be different characters. Staff arrange a variety of art activities in response to children's interests. For instance, children enjoy painting and explain how the leaves on trees change colour. Staff provide quieter times and space for children to relax and read the books.

Personal development, behaviour and welfare are good

Children are happy and follow the familiar routine at the club. Staff use a consistent approach to help children understand the boundaries. Staff are positive role models. They teach children about values, and children learn about each other's cultures and languages. For example, staff arrange interesting activities to celebrate different festivals around the year. Children are respectful and their behaviour is good. Staff are kind and caring. They encourage children to be as independent as possible. Children help to prepare dishes for snack and dinner, and help themselves to a drink of water or milk. They follow hygiene routines often without reminders. Staff teach children about leading healthy lifestyles, including keeping physically active on daily basis.

Frizz Kidz Club registered in 2012. The club operates from a single-storey sports pavilion building in the London Borough of Hounslow. The club is open every weekday before and after school from 7.30am to 8.45am and from 3pm to 6pm, during term time only. Holiday activities run from 8.15am to 6pm on weekdays during the main school holidays. Children are collected from Nelson Primary School and St Edmunds Primary School. The club employs four members of staff. Of these, three staff hold appropriate childcare qualifications.
