# Summary of key findings for parents

## This provision is good

- Children are happy and settled. They have good levels of self-esteem and form positive relationships with the childminder and each other which help to support their emotional well-being effectively.
- The childminder has a good understanding of children's individual needs. She monitors their progress and plans for what they need to learn next. Children make good progress in their learning.
- Children behave well. They show kindness and consideration to others and understand they need to take turns, for example, when playing the puzzle game.
- Effective partnerships are established with parents. The childminder shares information about children's care, learning and development to keep parents well informed.
- The childminder has a positive attitude towards the development of her childminding role and continues to update her knowledge such as through attending training.

# It is not yet outstanding because:

- The childminder does not make the best use of all opportunities to extend children's mathematical learning and understanding.
- The childminder does not provide a broad range of writing opportunities for children to extend their early literacy skills to the highest level.

# What the setting needs to do to improve further

#### To further improve the quality of the early years provision the provider should:

- make better use of opportunities to widen children's mathematical understanding more effectively
- provide more opportunities to support children's early literacy skills.

#### **Inspection activities**

- The inspector observed activities and interaction between the childminder and the children, and looked at the play equipment and resources.
- The inspector spoke with the childminder at appropriate times throughout the inspection including discussing the impact of teaching after viewing activities.
- The inspector viewed the areas of the premises used for childminding and talked to the children at appropriate times.
- The inspector looked at documentation including a sample of children's records and assessments.
- The inspector discussed how the childminder evaluates her provision.

# **Inspection findings**

#### Effectiveness of the leadership and management is good

Safeguarding is effective. The childminder provides a secure and welcoming environment and is clear about her role to keep children safe. She teaches the children how to keep themselves safe, for example, to sit properly on their chairs so they do not fall. The childminder monitors children's progress effectively. She uses the information to support children's learning and help them move on in their development. Parents receive regular information about their children's individual achievements. The childminder recognises the importance of continuing to improve her provision to benefit children. For example, she adds resources and researches new ideas to support children's speech development.

#### Quality of teaching, learning and assessment is good

Children are happy and settled, and enjoy their time at the childminder's setting. They enjoy a good selection of play activities and experiences that keep them interested and occupied. The childminder interacts positively with children, encouraging conversation and activities to develop their language skills effectively. For example, children have fun joining in with the songs and action rhymes as they play. Children giggle with excitement as they take part in physical games outdoors. They show good control as they steer their bikes taking care not to bump into obstacles. The childminder takes children on regular outings, including visits to other childminders, to widen their experiences and enable them to socialise with other children.

## Personal development, behaviour and welfare are good

The childminder's warm and friendly manner helps children build secure attachments. She works supportively with families to find out about each child's individual needs so she can help them settle. Children are valued and respected. For example, the childminder makes sure that all children can take part in play activities such as collecting seeds from the pumpkin. Children play together well. For example, they happily share and take turns as they pass the pumpkin over to others saying, 'now it's your turn'. The childminder teaches children about differences between themselves and others and to respect others.

#### Outcomes for children are good

Children make good progress. They develop positive social skills and show good levels of independence. For example, they are self-assured as they move around the play space and happily make choices about their play activities. Children gain essential skills to help prepare them for their future and in readiness for school such as learning to dress themselves. For instance, they show perseverance and care as they learn to zip up their coats, proudly telling others, 'I did it,' boosting their confidence and self-esteem.
