The effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection

The home was judged as requires improvement at the last full inspection. At this interim inspection, Ofsted judges that it has declined in effectiveness.

Since the last inspection, there has been one change to the young people living in the home. One young person has left the home to go to a different residential placement, and one young person has moved into the home.

Young people place themselves at risk both inside and outside the home. There are concerns regarding young people smoking cigarettes and cannabis in the home. Some young people are at risk of sexual exploitation, but continue to have periods of unauthorised absence from the home. This means that safeguarding arrangements in this home are ineffective and leave young people at risk of harm.

Recording of unauthorised absences and behavioural incidents is not consistent, and young people are still not receiving independent return interviews. This means that patterns of episodes of missing for young people are not correctly identified, and there is no management oversight of physical restraints to monitor and safeguard young people.

Poor maintenance of the home is an ongoing issue. Damage to the home highlighted at a previous inspection has not been repaired. This leaves parts of the home in a less than suitable condition and has an undesirable impact on the young people.

The manager ensures that young people's attendance and engagement with education continue to be good. Young people make good educational progress, and staff work positively and proactively with education providers to promote their learning and educational achievement

The manager continues to ensure that young people are registered with primary healthcare services and are supported to attend any appointments. Specialist support is readily available to meet the emotional needs of young people through individual therapeutic sessions. Appropriate arrangements are in place for the safe management of medicines, to promote the safety and well-being of young people.

The manager continues to ensure that young people are supported to maintain contact with their families. Staff support contact effectively by ensuring that transport is available and that any restrictions to contact arrangements are clearly known. This ensures that young people remain close to individuals who are important to them and benefit from being involved in a wider support network



outside of the home.

The manager ensures that young people continue to be protected by the organisation's robust recruitment practices. Health and safety matters are managed effectively, to promote the safety and well-being of young people.

Seven requirements and two recommendations were made at the last inspection. The registered manager has made some progress in addressing these. The home's children's guide has been updated, and missing-from-care reporting is in line with police protocols. There are improvements in partnership working with the police and in the independent monitoring of the home. However, requirements made regarding the recording of missing from care, behavioural incidents and damage to the home have not been addressed and have, therefore, been repeated.



Information about this children's home

The home is one of four in this private organisation that offer placements for up to three young people who may have a combination of mental health, psychological, emotional or complex care needs that present challenging behaviour. The service offers medium- to long-term placements.

In addition, the inspectors have tried to understand what the children's home knows about how well it is performing, how well it is doing and what difference it is making for the children and young people m
