### Summary of key findings for parents

#### The provision meets requirements

- Staff have established good partnerships with parents and the primary school where the club is located. This helps them to promote continuity of care and learning for children and supports their emotional well-being.
- The manager and staff have a clear knowledge and understanding of how to safeguard children. They have attended relevant training and know what procedures to follow if they have any concerns about a child's welfare. This helps to keep children safe from harm.
- The manager demonstrates a clear commitment to making continuous improvements to the club. This supports improvements within the setting and enhances future opportunities for children.
- The manager and staff understand how to support children's healthy lifestyles. They discuss the importance of providing children with a variety of balanced snacks and understand the benefits of physical play.
- Children are assigned a key person who will work closely with them. This helps to make sure that activities are appropriate for each child and their needs are carefully considered.
- The manager and staff team understand how to positively manage children's behaviour. They have a good understanding of the importance of providing clear boundaries so children know what is expected of them when in the club.
- Staff understand the importance of encouraging children to be independent throughout their play and daily routines. This contributes towards promoting children's self-esteem and developing their confidence.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.



#### **Inspection activities**

- The inspector engaged in discussions with staff and children throughout the inspection at appropriate times.
- The inspector viewed all areas of the premises used by children.
- The inspector discussed with the provider how they intend to complement the educational programmes when children are present.
- The inspector checked evidence of staff qualifications and their suitability to work with children and the club's improvement plan.
- The inspector looked at documents and discussed issues relating to the management of safeguarding children within their care.

Time Out at South Milford was registered in 2008. The club employs six members of childcare staff. Of these, five hold appropriate early years qualifications. The club opens from Monday to Friday, term time only. Sessions are from 7.30am until 9am and from 3pm until 6pm.
