## Summary of key findings for parents

## This provision is good

- Children and babies are cared for in a well-resourced and welcoming environment. They have easy access to a wide range of toys, inside and outside, which supports their learning and independence. Children make good progress and are well prepared for the next stage in their learning.
- Staff provide high-quality care. Children show good levels of confidence and are motivated to try new activities that staff plan for them.
- Staff seek advice and support from other professionals to help support children who have special educational needs or disability effectively.
- Partnerships with parents are good. Staff regularly share information with them to keep them informed about their children's progress. Parents are encouraged to complete their own observations of children's learning and experiences from home. This encourages a shared approach to supporting children's learning.
- Staff have good links with other professionals. For example, they are proactive in developing links with schools, to help support children when starting school.

#### It is not yet outstanding because:

- Staff sometimes miss opportunities to build on children's interest in writing to help extend their learning further.
- Staff have not fully considered ways for all children to share experiences from different parts of their lives with each other.

# What the setting needs to do to improve further

#### To further improve the quality of the early years provision the provider should:

- make the best use of opportunities to support children's independent writing skills
- provide opportunities for all children to share their experiences and knowledge from different parts of their lives with each other.

### **Inspection activities**

- The inspector observed the quality of teaching during activities and assessed the impact this has on children's learning.
- The inspector carried out a joint observation with the manager and they discussed their findings.
- The inspector spoke to the manager about the methods she uses to self-evaluate the provision.
- The inspector spoke to staff about their knowledge of child protection and the procedures they follow to keep children safe.
- The inspector viewed learning documents and spoke to staff about their knowledge of their key children and how they were supporting their learning.

# **Inspection findings**

#### Effectiveness of the leadership and management is good

Safeguarding is effective. The manager and staff are clear about their responsibility to report any safeguarding concerns they have about children. Staff are supported well in their roles. For example, they are provided with individual support and staff observe each other's practice to help them develop their skills and raise the quality of teaching. The manager and staff work together well to review the provision and make ongoing improvements. The management team monitors and tracks the progress of all children and any gaps in learning are quickly addressed.

#### Quality of teaching, learning and assessment is good

Staff use regular observations and assessments effectively to plan the next steps in children's learning. They know their key children well and regularly share information with each other, for instance, during planning meetings to help support children when moving on to the next room. Babies and toddlers receive good levels of support during their play and independently explore and investigate. For example, toddlers use the 'tunnel' to move between the rooms and babies develop a sense of who they are through exploring mirrors. Staff carefully plan for the children's day and offer a range of enjoyable activities that engage children in their learning effectively. Children practise their counting skills, for example, when adding ingredients to 'potions'. Staff confidently change their daily plans to meet the needs of the children and to use spontaneous opportunities, such as taking toddlers out to the park.

#### Personal development, behaviour and welfare are good

Children are settled and emotionally secure. They behave well. Staff boost children's self-esteem, including praising their positive behaviour, efforts and achievements. Staff have a clear understanding of babies' individual needs. For example, they work very closely with parents to provide consistent care routines that reflect babies' home experiences. Staff support children's healthy lifestyles well. For example, children are offered nutritious home-cooked meals and a variety of physical activities in the well-equipped outdoor area. Children learn about keeping themselves safe, such as using role play road signs to learn about road safety.

#### **Outcomes for children are good**

Children achieve expected levels of development typical for their age. Babies enjoy exploring sensory experiences such as shiny pebbles. Children learn about caring for living things, such as taking turns to look after the nursery hamster. They have good opportunities to practise skills that support their readiness for school. For example, children sit and listen well during a group story and know to put up their hands to ask questions.

Enchanted Nursery registered in 2011. It is situated in Alton, Hampshire. The nursery is open each weekday from 7.30am until 6pm for 51 weeks of the year. It closes for a week at Christmas and for bank holidays. The nursery receives funding to provide free early education for children aged two, three and four years. It employs 22 members of staff, including the management team. Of these, 14 hold appropriate early years qualifications.
