## Summary of key findings for parents

## The provision meets requirements

- The manager and her team have many years' experience in working with children and their families. They understand the importance of safeguarding children. The staff team are fully aware of the requirements they must meet and are aware of their individual responsibilities to keep children safe from harm and abuse.
- The manager and staff demonstrate their knowledge of the seven areas of learning. They fully understand how very young children learn and the importance of planning for their individual learning. Staff explain how they use observation and assessments to identify children's next steps in learning.
- The manager and her staff understand the benefits of working in partnership with children's parents. In addition, they fully recognise the importance of working with other agencies to ensure a consistent approach to children's care and learning. The manager and her staff describe how they reflect on their practice.
- The manager describes how she and her staff are encouraged to keep their childcare knowledge up to date. They describe the training courses they have undertaken and have planned to attend in the future.
- The manager and her staff understand the importance and benefits of identifying their strengths as a group and as individuals in order to improve and ensure positive outcomes for parents and their children.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

### **Inspection activities**

- The inspector spoke with the manager and her staff throughout the inspection.
- The inspector viewed the areas of the setting that are used by the parents and the children.
- The inspector discussed with the manager and her staff how they plan to meet the requirements of the early years foundation stage and promote children's progress.
- The inspector checked a range of documentation including the suitability checks of all staff working on the premises, training certificates and policies.
