Summary of key findings for parents

This provision is good

- The childminder has successfully addressed all the actions and recommendations raised at the last inspection, which demonstrates a good capacity to improve.
- The quality of teaching is very strong. The childminder interacts effectively with the children, helping to support all aspects of children's development. She challenges children's thinking through a very good range of questioning techniques. As a result, children are making very good progress.
- Partnerships with parents are very good. The childminder identifies children's previous learning through discussions with parents. This, and initial assessments, makes sure that children's starting points are clear from the beginning. Regular exchange of information means that parents can continue their child's learning at home.
- Children's emotional well-being is promoted effectively. Children form strong relationships quickly with the childminder who is responsive to their needs. The childminder gives lots of praise to children during activities, supporting their good selfesteem.
- The childminder ensures that children develop good independence skills. Children manage their personal hygiene needs appropriately for their age in readiness for school.

It is not yet outstanding because:

Information about children's development is not always used to best effect in focusing on how to raise their achievements to outstanding levels.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

strengthen the monitoring of children's progress and plan the next steps in their learning more precisely, helping children to achieve at the highest levels.

Inspection activities

- The inspector observed the quality of teaching during activities and assessed the impact this has on children's learning.
- The inspector completed a joint observation with the childminder.
- The inspector held discussions with the childminder. She looked at relevant documentation, such as her self-evaluation, children's developmental records and evidence of the suitability of adult household members.

Inspection findings

Effectiveness of the leadership and management is good

Arrangements for safeguarding are effective. The robust range of policies and procedures is updated regularly; implemented effectively and help to support the childminder's daily practice in ensuring children are kept safe and protected from harm. The childminder has a good knowledge of safeguarding and knows the procedures to follow if she is concerned about a child in her care. The childminder understands the importance of reviewing her practice. Improvements to her observations and assessments have resulted in her having an accurate understanding of children's development and how to support their future learning. The childminder keeps her knowledge and skills up to date through training and attending regular childminder forums.

Quality of teaching, learning and assessment is good

The childminder makes regular observations of children and accurately assesses their progress. She identifies clear next steps for learning and shares these with parents. This means everyone works together to promote children's learning and development. Children are highly motivated learners who embrace the high-quality learning opportunities on offer. Young children concentrate for significant periods of time as they are provided with challenging activities. The childminder recognises when children need more challenge and extends activities accordingly. Towards the end of a biscuit making activity she engages children skilfully adapting the activity, in order to continue to build on their small physical skills.

Personal development, behaviour and welfare are good

Children are happy, relaxed and move very confidently within the childminder's home. The childminder is a very good role model and provides children with a nurturing and caring environment. Children are affectionate towards the childminder. They are extremely well behaved and have excellent manners, which the childminder recognises and praises the children for. The childminder provides them with clear boundaries and expectations for behaviour. Children are provided with healthy foods and drinks and she engages then in food preparation to develop their understanding of healthy food options. For example, children help to make dessert and the childminder talks to the children about having a balanced diet. Children engage in activities that develop their understanding of healthy lifestyles, recycling and dental health. Young children are aware of the need for good hygiene and carry out handwashing routines independently.

Outcomes for children are good

All children acquire the skills, knowledge and attitudes to learning that prepare them well for starting school. They know and can follow daily routines. Children are motivated learners who embrace the high-quality learning opportunities on offer. All children, including those who speak English as an additional language, are making very good progress. Children are independent and sociable; they explore their environment with confidence, and feel happy and secure. They communicate effectively, confidently expressing their thoughts and ideas.
