Summary of key findings for parents

This provision is inadequate

- Children's safety and welfare are compromised. The provider does not meet the Early Years Register and the Childcare Register requirements. They have failed for almost two years to ensure that there is at least one member of staff with a current paediatric first aid qualification on the premises at all times when children are present.
- The provider does not ensure all staff have a secure, up-to-date knowledge of all safeguarding issues, and the safeguarding policy and procedures are not implemented consistently. These weaknesses place children's safety and well-being at further risk.
- The provider does not supervise staff effectively or provide support to improve their practice, raise the quality of teaching and improve outcomes for all children. This was a weakness identified at the previous inspection, which the provider has failed to address. Self-evaluation is poor and does not identify all weaknesses in practice.
- Staff do not assess the oldest children's abilities accurately to support them to make sufficient progress. Staff do not have a secure understanding of each child's individual needs and do not know if children require additional help or need greater challenge.
- Children do not have sufficient understanding of similarities and differences between themselves and others. This limits their understanding of the world.

It has the following strengths

Some room leaders know the children well and communicate sensitively with parents, for example, when sharing their child's progress check at two years of age.

Inspection activities

- The inspector explored the safeguarding arrangements, the security of the premises and how effectively the leaders have identified and taken steps to minimise any potential risks.
- The inspector looked at a range of documentation, including children's learning journals, assessments and staff's planning for children's activities.
- The inspector held a meeting with the provider and senior management team to discuss in detail leadership and management, staff supervision arrangements and the evaluation of the setting for quality improvement.
- The inspector spoke to a selection of staff, parents and children and took account of their views on the day of the inspection.
- The inspector observed the quality of teaching during activities, indoors and outdoors, and assessed the impact of this on children's learning.

Inspection findings

Effectiveness of the leadership and management is inadequate

Safeguarding is ineffective. The provider has failed to ensure that at least one member of staff with a current paediatric first aid qualification is always on site and available to respond at all times when children are present. The inspector has identified that this has been a breach of requirements at the end of every day for nearly two years. This significantly compromises children's safety and well-being. Children's welfare is placed at further risk because the provider has not ensured that all staff have a secure and up-todate knowledge of all safeguarding issues. Some staff do not know how to respond to all the possible signs and symptoms that a child may be at risk of harm, or how to refer concerns to the appropriate agencies in a timely manner. The provider has not taken any action to address a weakness identified at the previous inspection regarding staff supervision arrangements. Staff do not receive support to improve the quality of their teaching or identify gaps in their professional knowledge to raise the standards for all children. The processes for self-evaluation have not been established. Although staff talk to parents each day about their children, they do not seek their views about the service they and their children receive. Managers and staff do not recognise when there are breaches of requirements or reflect sufficiently on their practice to identify areas for development.

Quality of teaching, learning and assessment is inadequate

Despite the majority of staff being well qualified, the quality of teaching is inadequate in most areas of the nursery. Staff obtain some information from parents on entry, but this is mainly focused only on children's care needs. They gain insufficient detail about children's prior learning to plan for their development accurately from the start. Since the previous inspection, most assessments have been inaccurate, For example, staff do not complete initial assessments quickly enough to enable them to identify purposeful next steps in learning for each child. Staff do not assess the oldest children's progress accurately to plan for their future learning. For example, children's individual development needs are not met effectively as not all staff have an accurate view of how each child learns. Staff do not link planned activities consistently to each child's learning needs. Some activities lack purpose and do not fully engage children. However, staff in the toddler room plan exciting activities to help develop young children's early shape recognition. For instance, staff asked children to hunt for the shapes around the room, then extended this to finding shapes hidden in a tray of pasta.

Personal development, behaviour and welfare are inadequate

The continued breach of first aid qualification requirements and staff's lack of understanding of safeguarding mean that children's safety and welfare cannot be assured. Staff do not do enough to support children, including those who are learning to speak English as an additional language, to understand and celebrate each other's differences. For example, staff miss opportunities to share children's home languages and cultures and do not encourage them to learn about the world beyond the nursery door. Behaviour is good; children understand the nursery rules.

Outcomes for children are inadequate

Due to weaknesses in teaching and assessment, children make inadequate progress. Planned activities do not sufficiently motivate the oldest children to learn. Children enjoy writing and copying words they see, for example, on their toys, but staff do not build on their interests effectively. Children are not well-prepared for future learning and for school. Young children make progress in their early language development, such as when they begin to say simple words.

Woodlands Nursery registered in May 2005. It operates in Church Crookham near Fleet. The nursery opens from 8am until 6pm, Monday to Friday, all year round with the exception of Christmas week and bank holidays. There are nine members of staff who work with the children. Of these, seven hold relevant childcare qualifications at level 2 and above.
