Summary of key findings for parents

This provision requires improvement. It is not yet good because:

- The provider does not have effective staff supervision and coaching arrangements in place. She does not monitor practice well and help to improve staff's personal effectiveness, to raise the quality of the provision to a consistently good standard.
- Self-evaluation is not precise enough to accurately identify all areas for development. This remains an area for the provider to improve since the last inspection.
- Staff do not communicate with parents as well as possible. They do not regularly find out about children's interests, or give parents detailed information about the setting's policies and procedures and the role of the key person.

It has the following strengths

- Children enjoy their leisure time at the club. They happily play with friends and siblings and make choices from the toys and resources that staff set out for them each day.
- Staff are kind and caring towards the children and show interest in their play.
- Children's behaviour is very good. They respect the staff, who have high expectations of the children keeping to the rules and boundaries.

What the setting needs to do to improve further

To meet the requirements of the early years foundation stage the provider must:

To further improve the quality of the early years provision the provider should:

- reflect more rigorously and develop self-evaluation methods across the team to ensure that points for improvement are targeted in order of priority, to improve experiences for children
- develop communication with parents further by sharing more information about children's play preferences, the key-person role, and the group's policies and procedures.

- The inspector observed the children's play activities and snack-time routine.
- The inspector held a meeting with the manager about leadership and management, discussed self-evaluation and looked at relevant documentation.
- The inspector talked to parents and children and took account of the parents' views.
- The inspector carried out a joint observation with the manager.

Inspection findings

Effectiveness of the leadership and management requires improvement

The provider has made few improvements since the last inspection. Self-evaluation is not strong enough to ensure areas for improvement are consistently identified and acted upon. Safeguarding is effective. All the staff are first-aid trained and know who to contact if they have any concerns regarding a child's welfare. There are some arrangements in place for the induction of new staff. However, appraisals and supervision meetings are not used effectively to identify areas where individual staff can improve their personal effectiveness and knowledge of their role. The club has a good relationship with the host school and shares information with teachers about the children to support consistency in their care.

Quality of teaching, learning and assessment requires improvement

Children independently choose from a suitable range of play resources which engages them throughout the session. For example, they build and design with construction sets, colour in Christmas crafts and learn sewing skills. Children enjoy regular baking activities such as making sausage rolls. Staff and volunteers take on a directive, supervisory role with the children, telling them what to do instead of developing the children's own expressive ideas. Staff miss opportunities to chat and have conversations with children during their play activities, to encourage social and communication skills fully. Staff practice is inconsistent and not all staff have the necessary skills to support children. Staff do not provide sufficient resources suitable for those children who want to relax and rest after a busy school day.

Personal development, behaviour and welfare require improvement

Staff gain some information from parents to help meet children's individual care needs when they first start, but not a complete picture of children's play preferences and interests. Although the children are assigned a key person, when this changes staff do not always pass this information on to parents. The methods used to share information about policies and procedures with parents are not consistently good to ensure they know how the club is run. Children are happy, confident individuals who build suitable relationships with the friendly staff. Children are familiar with the routines of the club and for their health and safety. For example, they understand the importance of hygiene routines and wash their hands at the correct times. Overall, staff provide healthy snack choices for children and manage snack time well with some emphasis on encouraging children's personal independence. This supports them in developing the skills they need when attending school.

Ropley Breakfast and After School Club registered in 2008. It is one of two settings run by the Trustees of Alresford Youth Association. It operates from Ropley Church of England Primary School in Ropley, Hampshire. The club operates Monday to Friday during term time only. It opens before school from 7.30am to 8.45am, and after school from 3pm to 6pm. There are currently two members of staff employed to work with the children. Of these, one holds an appropriate qualification.
