Summary of key findings for parents

This provision is good

- Caring and friendly staff understand children's individual needs and routines well, which helps children to feel safe and secure. New children settle in quickly.
- Staff complete regular and precise assessments of children and use these effectively to plan suitably challenging activities. Children are keen to explore the well-organised play areas and make good progress in their learning and development.
- There is a strong commitment to partnership working with parents, external agencies and other carers should staff have a concern about a child's development. Leaders monitor children's progress and collate all information to form individual plans to help close any gaps in learning.
- Leaders give good support to staff and encourage their continued professional development to extend their teaching skills further. For example, following behaviour management training, all staff are consistent in their routines and management of behaviour, and children behave well.
- Leaders and staff evaluate practice regularly. Ideas from parents and children help to identify the most significant actions to raise the quality of the provision even higher.

It is not yet outstanding because:

- At times, staff do not support children to extend their thinking skills further.
- Staff do not make full use of all opportunities to support children's understanding of letters as part of their early literacy development.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- enrich children's thinking skills to higher levels during their play, learning and daily routines
- increase opportunities to extend further children's understanding of letters and their sounds.

Inspection activities

- The inspector observed interactions between staff and children and the impact these have on children's learning.
- The inspector carried out a joint observation with the manager.
- The inspector examined a range of documentation, including children's records, staff planning, risk assessments, some policies and recruitment procedures.
- The inspector held discussions with two senior managers, the setting's manager and staff, and talked with children and parents.
- The inspector checked evidence of staff's suitability checks and qualifications.

Inspection findings

Effectiveness of the leadership and management is good

Leaders have a clear understanding of their responsibilities in meeting the requirements of the early years foundation stage. Safeguarding is effective. Staff have a strong understanding of how to safeguard children's welfare. For example, staff have up-to-date skills and knowledge to deal with any concerns or accidents. They maintain documentation well and keep parents fully informed of any changes to policies and procedures, and about their children's development. Parents' testimonials are very complimentary in their praise of the setting. They state that their children are 'extremely happy' and 'thrive since joining'. Leaders have addressed the recommendations from the last inspection. For example, all resources and activities are well labelled and easily accessible to support children to make choices in their learning.

Quality of teaching, learning and assessment is good

Staff engage themselves fully in children's play, extending their language through positive interactions and timely discussions. They support children's numeracy skills well. For example, staff provided damp sand for the youngest children to make pies, which they handled confidently, developing their physical skills. Staff described and counted the pies, increasing children's vocabulary and awareness of number order. The oldest children explored interesting resources as they discussed dental hygiene. Staff extended their learning, hiding laminated pictures of teeth with numbers on them for children to find. Staff encouraged children to recognise numerals and introduced new vocabulary, such as 'molars', as they talked about what was happening.

Personal development, behaviour and welfare are good

Children are very happy and they frequently smile and laugh as the friendly staff join in with their games. Staff place a keen focus on developing children's communication and social skills, for example, through the use of hand signs and songs for daily routines. Staff display kindness, respect and consideration for the feelings of others, and children copy this thoughtful behaviour. The welcoming play areas provide all children with easy access to age-appropriate toys and activities, including those that reflect the local community and wider world. Staff support children's health and physical development through daily routines and indoor and outdoor play times, including forest activities.

Outcomes for children are good

Children are confident and well-motivated to learn. They become increasingly independent, for example, by finding their own bags and coats, and self-register on their arrival. They develop their mathematical skills, learning to recognise numbers. All children, including funded children, make consistently good rates of progress from their starting points. They are well prepared for their next stage of learning, including school.

Stonehouse Park Children's Centre registered under the current management in 2013. It is located on an infant school site in Stonehouse, Gloucestershire. It operates from the Red Lodge Building. The children's centre is open each weekday from 8.30am until 4.30pm, all year round. The early years provision is open term time only from 9am to 3pm. The setting receives funding for the provision of free early education for children aged two, three and four years. A team of 12 staff works directly with the children. Of these, one holds early years professional status, one holds qualified teacher status, and eight hold a relevant childcare qualification at level 3.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
