Summary of key findings for parents

This provision is good

- Children are happy and confident in the warm and caring environment the childminder creates. She knows the children well and they develop secure attachments with her.
- The childminder plans creative and challenging activities which engage the children. For example, children thoroughly enjoyed investigating how torches work and used them to hunt for animals hidden around the setting.
- Children enjoy interesting interactions with the childminder as she joins in with their play. Children listen to her well and she supports their communication skills effectively.
- The childminder reflects on her practice and is committed to extending her knowledge, keeping up to date with current legislation and improving her teaching. For example, she is completing training on outdoor play which is helping support children's physical and confidence-building skills.
- Children make good progress that is typical for their age. The childminder monitors children's progress well and uses information from her assessments to plan for their next steps in learning.

It is not yet outstanding because:

- The childminder does not consistently provide opportunities for children to learn about cultures and languages within and beyond their own experience.
- The childminder does not make the most of opportunities to develop children's understanding of the importance of healthy eating.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- build on the opportunities for children to learn more about cultures and languages beyond their own experiences
- extend opportunities for children to learn more about the importance of healthy eating.

Inspection activities

- The inspector observed children and their interactions with the childminder as they engaged in activities.
- The inspector spoke to the childminder about children's learning and progress.
- The inspector discussed safeguarding practices with the childminder.
- The inspector sampled a range of documentation including children's learning records, and policies and procedures.
- The inspector took account of the views of parents.

Inspection findings

Effectiveness of the leadership and management is good

Safeguarding is effective. The childminder knows her role and responsibilities in keeping children safe and what action to take if she has concerns for children's welfare. The childminder has met the recommendations set at her last inspection and seeks the views of parents and children to help evaluate and improve her provision. She develops good relationships with parents whose feedback is positive. Parents particularly value the range of creative outdoor activities and trips the children enjoy. For example, children explore local woods and parks daily, go fruit picking and visit London by train. The childminder shares information with professionals in other settings children attend, to help support consistency in children's learning and development.

Quality of teaching, learning and assessment is good

The childminder has a good understanding of how children learn and develop. She plans activities based around children's interests and next steps so that children are motivated to learn. She encourages children's curiosity and supports them in meeting new challenges. For example, children explore how to mend a torch using a screwdriver, how to break open a pumpkin safely with a mallet and how suction pads stick to surfaces. The childminder develops children's language skills well. For example, she asks questions to encourage thinking, models how to say words and introduces new vocabulary such as 'groove' and 'tricky'. The childminder encourages the development of babies' physical skills. For example, she ensures there is clear space for crawling, toys to roll across the floor and different textures to explore.

Personal development, behaviour and welfare are good

The childminder supports children's physical and emotional well-being successfully. She comforts children warmly and gives them lots of praise and encouragement. For example, she thanks children for being helpful and celebrates when they use new words. She is sensitive to the needs of individual children and works closely with parents to personalise children's care routines. The childminder has clear and consistent expectations of behaviour effectively. For example, older children share toys and play with younger children gently. The childminder supports children's learning of good hygiene. For example, children know why they need to wash their hands before eating.

Outcomes for children are good

Children are active learners and are well prepared for the next stages in their education. They learn to be independent in meeting their care needs such as taking off their own coats when they come in from the garden. They acquire good mathematical skills, for example, as they identify shapes, match colours and count how many eggs can fit in an egg box.
