Summary of key findings for parents

This provision is good

- All children make good progress in all aspects of their learning and development. They are inquisitive and enthusiastic learners and develop their imaginations well.
- The childminder observes children's play precisely. She uses children's chosen activities to extend their learning well. She has a good knowledge of development in young children, identifying any gaps and providing support and opportunities so that children catch up quickly.
- The childminder maintains a strong partnership with parents so that they receive accurate information about their children's progress and are fully involved in supporting the next steps of learning at home.
- Children are secure and confident, eagerly exploring and investigating. They relate well to each other.
- The childminder continually checks and reflects on her practice, including the views of parents and children. Using these and her own study, she makes continual improvements that help her support children more sensitively in line with their needs.

It is not yet outstanding because:

Sometimes, when working with groups of children, the childminder does not help them to consider and understand fully what they learn. She does not use clear language with the youngest children to extend their vocabulary and understanding of what they have achieved.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

work more effectively during group times with children, to help them consider and understand what they learn, using clear language with the youngest children to extend their vocabulary and understanding of their achievements further.

Inspection activities

- The inspector observed the children playing with the childminder, and the quality of her teaching and care of them.
- The inspector spoke to the childminder at convenient times.
- The inspector completed a joint observation with the childminder to discuss children's learning and progress.
- The inspector examined relevant documents, including written feedback from parents, and discussed aspects of safety and safeguarding with the childminder.
- The inspector viewed the premises and the resources available.

Inspection findings

Effectiveness of the leadership and management is good

The childminder has improved her practice well since the previous inspection. She makes sure that her teaching continues to improve, for example, by including counting and mathematical language in daily activities. She keeps up to date with good practice and requirements through attending local childminder networks. The childminder works effectively with other providers that children attend to make sure that assessment is accurate and children have continuity in learning. Safeguarding is effective. The childminder has updated her knowledge of child protection issues. She knows the signs to look out for and who to contact if she has any concerns. She is vigilant about taking photographs and use of the internet, to reduce any potential danger to children.

Quality of teaching, learning and assessment is good

The childminder plans a good range of activities to interest children. She supplements these with regular visits to toddler groups, and to local lakes and woodland, for example. The childminder uses stories and songs well to stimulate children's understanding and early literacy skills. She questions and challenges older children well in a play dough activity, for example, to develop their knowledge of how many pieces they have when they cut it in half. The childminder presents good opportunities and resources for imaginative play, extending children's knowledge and using their own experiences well. The childminder makes sure that younger children have frequent opportunities to extend their sensory experiences. They explore with their fingers, make marks and develop the muscles in their hands for early writing.

Personal development, behaviour and welfare are good

The childminder has high expectations of children, who are courteous and treat each other with respect. Children have strong relationships with others and the childminder, who values and praises their contributions. Children share well, for example, making sure that they each have what they need for an activity, and they understand how to take turns. The childminder works well with parents to meet children's care needs and develop their independence, for example, so children learn to feed themselves and use the toilet unaided. The childminder provides a caring and nurturing environment, helping children to feel secure.

Outcomes for children are good

Younger children are inquisitive and responsive, eagerly moving to join in activities with older ones. They are expressive and communicate well with smiles and sounds, showing their delight in activities. Older children confidently join in conversations. They learn to use tools and pens well and participate enthusiastically in familiar songs and stories. All children are ready for the next stage of their learning.
