# Summary of key findings for parents

This provision requires improvement. It is not yet good because:

- Staff knowledge and understanding of some of the afterschool club's policies and procedures are not consistent. This means that assessment and monitoring of staff are not always effective.
- Planning for the indoor environment does not ensure children who enjoy creative activities are provided with a range of resources and materials necessary to interest and challenge them.
- Leaders do not sufficiently plan and organise snack times to provide opportunities for children to develop their independence. Children do not take an active part in the preparation and serving of food. This means at times children are not fully engaged in the activity.
- Individual staff supervision is not regular enough to ensure that staff have sufficient knowledge and understanding to implement policies and procedures effectively.

## It has the following strengths

- Children have good opportunities to be active and develop competent physical skills as they move confidently between the indoor and outdoor environments.
- Children are happy and settled as they enjoy positive relationships with staff.

## **Inspection findings**

#### Effectiveness of the leadership and management requires improvement

The arrangements for safeguarding are effective. There are relevant safeguarding policies and procedures in place. Managers do not hold regular supervision meetings with staff. Consequently staff do not have clear targets set to help them develop their practice. Weaknesses such as an insecure knowledge of policies and procedures are not identified or tackled effectively in order to drive improvement. Staff attend a range of training opportunities however insufficient time is spent ensuring that their knowledge and understanding has been increased and is then embedded in daily practice. Managers have developed effective systems for sharing information with parents and the school to support and meet children's individual needs.

#### Quality of teaching, learning and assessment requires improvement

Leaders and managers do not provide a sufficient range of activities for all children to choose from. Outdoor physical activities are well planned and resourced. Indoor activities lack planning and preparation. Children are offered limited creative materials which do not provide sufficient interest and challenge. Staff do not consider all children's interests enough, consequently those children lose interest and do not take part. Staff practice is not always consistent. Some staff support children to build their confidence and to take part by offering praise and encouragement. Other staff do not ask skilful questions, or listen and respond to children's comments and questions in order to extend their interest and thinking.

#### Personal development, behaviour and welfare require improvement

Leaders and managers do not always support children's independence. Staff prepare individual savoury wraps, pour drinks and share out snacks, while children wait. Children do not actively contribute to these activities. Children show strong attachments to staff and form positive relationships. This enables children to develop confidence and feel secure and safe. Children show good control and coordination as they play together outside. Older children are caring towards younger children. They work as part of a team and understand what good behaviour is. Children know to wash their hands before they eat and that exercise keeps them healthy. They are aware of how to keep themselves safe by using only parts of the school that are available to them.
