Summary of key findings for parents

The provision meets requirements

- The childminder has a secure knowledge of child protection procedures. Since the last inspection, she has completed safeguarding training. This has enhanced her understanding of reporting any concerns about a child's well-being and safety.
- The childminder has a secure understanding of the learning and development requirements. She knows how to use observation, assessment and activities to promote and monitor children's learning and meet their individual needs.
- The childminder has taken action to minimise risks inside and outside her home, so that when children are on roll, they can play safely. She knows to supervise children. For example, she only allows older children to access the tree house in her garden.
- The childminder knows how to act a positive role model for children to help them behave well. She identifies clear aims to help children learn to be polite and to treat others with kindness and respect.
- The childminder fully understands the importance of self-evaluation. She has reviewed how she seeks parent's views so she can act on their suggestions. She knows how to offer parents ideas for activities to do at home to involve them in children's learning.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
