Summary of key findings for parents

This provision is inadequate

- The provider fails to meet the Early Years Register and Childcare Register requirements. She does not ensure that staff understand their safeguarding responsibilities or the need to inform her of anything that may affect their ongoing suitability, including by association. Staff do not know their role in preventing children from being at risk from extreme behaviours and views.
- The provider does not ensure all required records are available for inspection, including evidence of staff's suitability, qualifications and training, and public liability insurance.
- The provider has not informed Ofsted of changes to the manager and fails to ensure that managers have relevant skills. Staff do not receive effective monitoring to develop their practice and improve the quality of teaching. Self-evaluation is ineffective.
- The provider does not ensure drinking water is easily available for children at all times.
- The provider does not monitor the educational programme to ensure staff plan experiences which match children's individual learning needs, address any gaps in their development promptly, and ensure each child receives the support they need.
- Staff do not interact with children effectively. Children do not receive appropriate challenge and support to extend their learning. They do not have opportunities to use and develop their home languages. Children do not make sufficient progress.

Inspection findings

Effectiveness of the leadership and management is inadequate

Safeguarding is ineffective. The provider does not ensure staff understand their child protection responsibilities. For example, they do not know what to do if anything affects their ongoing suitability, including through their associations. The manager and staff do not have a secure understanding of emerging safeguarding matters. For example, they do not know the indicators that children may be at risk of being exposed to extreme views. The provider does not have all required documentation available for inspection. For example, she is unable to provide evidence of staff's suitability checks, records, qualifications or training. In addition, she does not have proof of valid public liability insurance. The provider has not informed Ofsted of the change of manager and has failed to ensure this person has relevant experience and skills for the role. Staff do not receive the supervision and support that they need to develop their teaching skills. Self-evaluation is not used effectively to identify areas of weakness and set targets for improvement. The manager ensures staff are deployed effectively to meet adult-to-child ratios and supervise children.

Quality of teaching, learning and assessment is inadequate

The provider does not oversee children's progress adequately. Staff do not identify and address gaps in children's development or ensure children receive the support they need. Key persons do not interact effectively with children to provide them with challenge and extend their learning to help them make good progress. The provider does not ensure staff plan activities to support children's next stage in development and reflect their individual needs. Children lack motivation and engagement. They do not maintain focus during activities, which hinders their learning experiences. Staff do not make good use of occasions, such as mealtimes, to develop children's communication and social skills. Children do not have opportunities to think for themselves. Partnerships with parents are established. Staff share a range of information with them to support their children's care and learning. This includes records of children's accidents and injuries, and details of any first-aid treatment given with the names of the witnesses. Staff share children's scrapbooks and development records with parents to support learning at home.

Personal development, behaviour and welfare are inadequate

The weaknesses in safeguarding have a significant impact on children's safety and welfare. In addition, children are unable to access drinking water easily, as required. This fails to support their well-being adequately. For example, at the inspection, children who had been at the setting since early morning could not access drinks freely until snack time. Staff do not value children's home languages to support their self-esteem effectively. Children generally behave well and staff provide clear guidance to develop their understanding of appropriate behaviour. Staff encourage children's self-care skills appropriately. They minimise the risk of cross infection and record any medication administered appropriately. Staff complete visual risk assessments, which help identify and minimise any hazards in the premises and provide a safe environment.

Outcomes for children are inadequate

Children are not well-prepared for their next steps in learning and their move to school. For example, they do not learn effective communication skills, including in their home languages, or how to think for themselves. Children develop some mathematical skills, such as counting and number recognition. However, they do not learn to concentrate and find it difficult to engage in purposeful play. Weaknesses in the quality of teaching mean that children do not receive adequate support to catch up where there are gaps in their development.

Jacqueline's Gems @ Manor Close registered in 2016 and is located in the London Borough of Bexley. It is one of multiple settings run by the same provider. The nursery operates each weekday from 7.30am to 6.30pm, all year round. There are six members of staff, five of whom hold relevant childcare qualifications at level 3. The nursery receives funding to provide free early education for children aged two, three and four years.
