Summary of key findings for parents

This provision is inadequate

- The childminder does not have a sufficient understanding of her role and responsibilities with regard to child protection. She is does not know the procedure to follow if an allegation is made against herself or anyone living or working on the premises.
- The childminder does not complete accurate assessments. This means she is unable to identify any gaps in children's learning or know whether they are making progress.
- The childminder does not complete the progress check for children between the ages of two and three years in a timely manner. Consequently, she is unable to identify any emerging concerns promptly or seek support from other professionals.
- The childminder does not carry out robust risk assessments in relation to sleeping children.
- The childminder does not keep a record of all complaints and their outcomes.
- The childminder's self-evaluation is not rigorous enough. It does not identify weaknesses in practice or maintain continuous improvements in the provision.

It has the following strengths

■ The childminder speaks to parents regularly about their child's care and achievements while in her provision. Parents comment that they are happy and satisfied with the service provided.

What the setting needs to do to improve further

Inspection findings

Effectiveness of the leadership and management is inadequate

The arrangements for safeguarding are not effective. The childminder has a poor understanding and knowledge of current child protection legislation and wider safeguarding issues. For example, the indicators that children are at risk of being exposed to different ideas about right and wrong. The childminder is not clear about the procedures to follow if she has concerns about children's welfare or what to do should an allegation be made against them. She is, however, aware of the known signs and symptoms of abuse and neglect. The childminder has kept her first-aid certificate and other mandatory training up to date. She is also aware of ensuring that all adults in the home have undergone suitability checks. The childminder has carried out some evaluation of her practice. However, this has not been effective in identifying key weaknesses of the provision. The childminder does not keep a record of any complaints and their outcomes.

Quality of teaching, learning and assessment is inadequate

The childminder does not make effective use of the information gained from her observations of children. Assessments of children's starting points and ongoing levels of achievement are inaccurate. This means the childminder does not identify gaps in learning, or monitor children's progress closely enough. As a result, she is not able to plan effective and challenging experiences based on what children need to learn next. Children are not provided with the stimulating activities they need to make good progress in their learning and development. The childminder does not complete the progress check for children aged between two and three years in a timely manner. As a result, she does not ensure there are opportunities to review children's development with parents, carers and other professionals.

Personal development, behaviour and welfare are inadequate

Weaknesses in leadership and management mean that children's welfare is not assured. Although the childminder has taken some steps to minimise risks in her home, she has failed to fully assess the risk of allowing two children to sleep in a travel cot at the same time. This compromises children's safety and well-being. Children have access to outdoor play and outings which contribute to their physical development and help them to learn about healthy lifestyles. The childminder guides children appropriately to help them understand what acceptable behaviour is. They are learning to share and take turns.

Outcomes for children are inadequate

Children are not supported to make good progress in their learning. Their well-being, learning and development are compromised due to weaknesses in the childminder's practice. Arrangements to monitor children's progress are not effective. Children are not learning the key skills necessary in readiness for school. Nevertheless, they are independent and self-motivated to take part in some activities in the well-resourced environment.
