# Summary of key findings for parents

#### This provision requires improvement. It is not yet good because:

- The childminder has not ensured that Ofsted has been notified of changes to her household to complete suitability checks, as required. This is also a breach of the Childcare Register.
- The childminder does not consistently create opportunities for children to extend their recognition of numbers.
- Children are not fully able to consistently develop their independence skills and manage tasks for themselves.

### It has the following strengths

- The childminder has developed effective partnerships with parents and other professionals. They share information regularly, which contributes to a shared, consistent approach to children's care and learning.
- The childminder provides a good range of resources and activities which reflect children's interests and stages of development. For example, children enjoy exploring sand, using their senses and physical skills.
- Children play cooperatively together and behave well. The childminder encourages children to learn to share, take turns and respect each other's feelings.
- The childminder liaises well with the local school teachers. Younger children become familiar with the school environment when accompanying the childminder on her regular school runs. This helps to support their move to school when the time comes.

## What the setting needs to do to improve further

# **Inspection findings**

#### Effectiveness of the leadership and management requires improvement

Safeguarding is effective. The childminder has a good knowledge of child protection and effectively implements her up-to-date policies and procedures. She is aware of who to go to if she has any concerns about a children's welfare. The childminder has not ensured that she has notified Ofsted of changes to her household, as required, so that suitability checks can be completed. The childminder regularly evaluates her practice to help her meet children's needs. For example, she attends training courses and uses the internet to update her knowledge. Partnerships with parents and other professionals are effective. For example, she communicates with them regularly and shares information about children's care and learning.

#### Quality of teaching, learning and assessment is good

The childminder observes and assesses children's learning and identifies their interests. She uses the information effectively to help plan for children's next steps in their development. For example, children are eager to take part in the treasure hunt using the natural resources collected on their trips to the forest. The childminder supports children's personal, social and emotional skills. For example, when children show an interest in dressing up and role play, the childminder provides them with a wide range of costumes. They dress up as super heroes and use their imaginary skills in their play. The childminder introduces some mathematical concepts into their play. For example, she asks children how many sides a square and triangle has during a construction activity.

#### Personal development, behaviour and welfare require improvement

The childminder has not ensured that Ofsted has been able to check the suitability of all adults in the household. However, unchecked adults are not left unsupervised with children, which minimises the risk to their welfare. Children are happy and confident in the childminder's care. She understands their moods, personalities and is attentive to their needs. Children are aware of other people's differences and similarities. For example, they look at a world globe and discuss different people's cultures and where they live. The childminder encourages children to be healthy. For example, they discuss what healthy foods they could put on top of their pizza for lunch. Children enjoy being active. For example, they regularly visit the local countryside and beaches.

#### **Outcomes for children are good**

All children, including those who need additional help to catch up, make good progress. Children are confident, curious and show an enthusiasm for learning. They enjoy looking at books, which helps them to develop their early literacy skills. Children develop a good range of skills which helps to prepare them for the next stage in their learning and eventual move to school.
