Summary of key findings for parents

The provision meets requirements

- Since her last inspection, the childminder has made improvements to her practice. When caring for children, she ensures her planning for each child covers all aspects of learning. She regularly observes and assesses children's development, and shares this information with parents.
- The childminder understands how to complete the progress check for children aged between two and three years. She shares these with parents and they give the childminder information on how children are developing at home.
- The childminder has a clear understanding of how to protect children's welfare. She understands how to keep them safe and is fully aware of the procedures to follow to report any concerns.
- The childminder reflects on her practice to make effective changes. She has recently purchased new resources for her garden, in order to further promote children's physical skills. She also seeks appropriate professional development opportunities to help her improve her teaching skills.
- The childminder understands how to prepare children for starting at school. She takes them to community groups so they have opportunities to socialise with others of their own age. The childminder also helps children develop good self-care skills, such as using cutlery and dressing themselves.
- The childminder understands the benefits to children when she works in partnership with other settings children attend. She is proactive in sharing development information with them to promote continuity in children's learning.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
