# **Summary of key findings for parents**

# This provision is good

- The childminder has taken appropriate action to address the issues raised at her last inspection. This has helped to improve the outcomes for children.
- Partnership working with parents is well embedded in practice. The childminder and her assistant build positive working relationships with parents to facilitate information sharing.
- The childminder uses appropriate tracking systems to assess the progress and development of each child. She is aware of how to secure and provide additional support for children who require it.
- The childminder gets to know children well. She establishes their starting points upon entry and regularly assesses their progress. She plans a range of activities which supports children's development in all areas of learning.
- The childminder and her assistant have fostered positive relationships with children. Children feel secure at the childminder's home and confidently approach the childminder, or her assistant, for support.

# It is not yet outstanding because:

- The childminder's evaluations of practice do not yet focus sharply enough on improving the quality of teaching.
- Sometimes, the childminder's focused activities do not reflect the individual needs and interests of each child.

# What the setting needs to do to improve further

## To further improve the quality of the early years provision the provider should:

- build on evaluation skills further, to focus more sharply on how the quality of teaching can be developed to an outstanding level
- revise how focused activities are planned and carried out, so that these consistently reflect the individual needs of each child.

## **Inspection activities**

- The inspector had a tour of the areas of the premises used for childminding purposes.
- The inspector reviewed feedback provided by parents during the inspection and took account of their views.
- The inspector spoke with the childminder and her assistant at appropriate times during the inspection. She looked at relevant documentation, such as the childminder's self-evaluation and evidence of her suitability and qualifications.
- The inspector observed the quality of teaching during activities indoors. She assessed the impact this has on children's learning.
- The inspector completed a joint observation with the childminder.

# **Inspection findings**

# Effectiveness of the leadership and management is good

The childminder has a good understanding of her role and responsibilities. She supervises her assistant appropriately and has introduced thorough recruitment procedures. The arrangements for safeguarding are effective. The childminder and her assistant both demonstrate a good understanding of child protection issues. They are aware of how to prevent children from being drawn into situations which could expose them to significant harm. The childminder has thorough risk assessment procedures in place, to identify and manage risks. She has recently completed a self-evaluation and has identified some relevant areas for development. Feedback from parents is sought regularly and children's interests and opinions are also considered.

# Quality of teaching, learning and assessment is good

Children enjoy their time at the childminder's home. They independently access two very well-resourced playrooms. The childminder and her assistant encourage children to follow their own interests during free play. Children play imaginatively, preparing meals for the childminder. She uses questions to help children remember previous learning experiences and information about their lives at home. Children's early literacy is well supported. The childminder's assistant reads children their favourite stories in an animated voice. Children are encouraged to guess what happens next. Younger children develop their physical coordination skills in a variety of ways. They enjoy using push-along toys, for example, or emptying and filling different containers. The childminder and her assistant undertake relevant training to refresh their knowledge of children's learning and development.

## Personal development, behaviour and welfare are good

Children feel confident to play alongside the childminder and her assistant. Children are developing an understanding of how they can keep themselves safe. They know, for example, that grapes must be chopped before they can eat them so that they do not choke. Children are responsive to adults and enjoy being praised for their good behaviour. For example, they are extremely enthusiastic as gold stars are added to their star charts. Children learn more about the world around them. They go on regular outings beyond their local community, as well as visiting play centres and playgroups. The childminder has devised secure procedures to help children settle in and to prepare them to move on from her setting. Children can manage their personal care routines independently, where applicable, and understand the importance of following hygiene routines.

## **Outcomes for children are good**

Children make typical progress from their individual starting points. They are developing the key skills which prepare them well for their next stages of learning and their eventual move on to school. Children communicate with confidence and manage their own feelings well, relative to their stages of development. They are actively involved in making decisions and choices about what they want to do next.
