- The childminder knows how to teach children about the behaviour expectations. She understands the importance of acting as a good role model for children, and how to help them negotiate and cooperate with others in their play.
- The childminder is aware of the importance of updating her professional knowledge, such as through further training, to help her improve outcomes for children.
- The childminder understands how to work together with her co-childminder and parents to evaluate practice and make improvements tailored to children's needs.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation.
