Summary of key findings for parents

This provision requires improvement. It is not yet good because:

- Systems in place to monitor and observe staff are not ensuring that teaching is consistently strong across the nursery.
- The staffing arrangements in place to support babies' emotional well-being and help them feel settled are not fully effective.
- Procedures to ensure that parents are aware of accidents require strengthening to ensure there is a clear record of information being shared.
- The nursery still developing more effective ways to engage with parents and ensure they are fully involved in their children's learning and development.

It has the following strengths

- Leaders and managers are ambitious and keen to develop the nursery further.
- Recent action has ensured that safeguarding policies and procedures have been strengthened and are understood by managers and staff.
- Parents praise the staff team and find them warm and approachable.
- The nursery premises are clean and safe. Security is good and ensures that no unwanted visitors can access the nursery.

What the setting needs to do to improve further

Inspection activities

- The inspector spoke to a few parents and took their views into account.
- The inspector spoke to staff and children at suitable times throughout the inspection.
- The inspector observed the quality of teaching and children's learning both indoors and outside.
- The inspector carried out a joint observation of teaching with the nursery manager.
- The inspector sampled the nursery's documentation, including records of children's learning, case notes and staff files.
- The inspector held meetings with the management team at the nursery.

Inspection findings

Effectiveness of the leadership and management requires improvement

Systems in place to monitor the quality of teaching across the nursery are not fully effective. For example, leaders do not ensure that staff complete children's records in a timely manner. New ways to observe, assess and plan for individual children have been introduced but are not being used well enough by some staff. New arrangements for room leaders to monitor the work of their staff are not yet making a positive difference. The management team has a clear sense of direction. They recognise the need to develop staff's understanding of good quality teaching and have plans in place to address this, including well-targeted training. Safeguarding is effective. A range of actions have been taken to improve the team's knowledge and understanding of how to keep children safe and manage any concerns. These include a full review of policies and procedures, training for both managers and staff and a safeguarding audit.

Quality of teaching, learning and assessment requires improvement

The quality of teaching is variable across the staff team. A sharper focus is needed on the development of children's speaking skills. This is an area where nursery records show that some children are not doing as well as could be expected. While some staff model language well, others miss opportunities to extend children's learning. For example, they do not talk about what the children are doing during their play or explain how things work. Staff are beginning to plan activities based on children's interests, such as space travel. This means that most children are generally well engaged during the day.

Personal development, behaviour and welfare require improvement

On the day of the inspection there were staff absences in the baby room. Nevertheless, routine arrangements to ensure that children feel comfortable in the nursery are not fully effective. For example, babies' nappies are changed by casual staff members. This does not support babies in developing secure attachments and at times babies were distressed. Older children enjoy their time at the nursery. Children of all ages go out in the fresh air every day, although the range of planned activities and resources outdoors is more limited than indoors. Good improvements have been introduced to encourage children's independence in readiness for school. For example older children wash their own hands, help to serve themselves at mealtimes and clear away their plates when they have finished. New ways to further involve parents, for example by increasing attendance at parents' evenings, are being developed.

Outcomes for children require improvement

There is more to do to ensure that children are making the best possible progress. For example, staff do not encourage older children to talk with them and share their news over lunch. Children learn about healthy lifestyles and try a range of fruits and vegetables. Staff have had recent training to help them manage children's behaviour in a positive manner. As a result, children generally behave well. When activities capture children's interest, they concentrate well. For example, babies make marks in wet sand and preschoolers enjoy mixing colours when making rainbow clouds. Most toddlers joined in enthusiastically with a music session during the inspection, making sounds with shakers.
