# Summary of key findings for parents

### The provision meets requirements

- The childminder understands the importance of establishing positive partnerships with parents. She is aware of the benefits of a consistent approach to sharing information to help support children's learning and progress.
- The childminder understands the importance of safeguarding children to help protect their welfare and keep them safe. For example, she knows who to contact and what to do in the event of any concerns regarding children's safety and welfare.
- The childminder understands the need to closely monitor and track children's development. She knows how children learn, and how to support them to make progress in their learning and help prepare them for school.
- The childminder continues to review her practice. For example, she attends regular training to keep up to date with current early years practice.
- The childminder recognises the importance of teaching children positive values. For example, she plans to teach children to be respectful and polite, and to behave well.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The childminder registered in 2006. She lives in Halling, Kent. She offers her service, Monday to Friday from 7.30am to 6pm, all year round. The childminder holds a relevant early years qualification at level 5. There were no children on roll in the early years age group at the time of the inspection. The childminder also has a separate registration to provide childcare on domestic premises.
