Summary of key findings for parents

The provision meets requirements

- The provider has a very good understanding of child protection and talks confidently about how staff will safeguard children. Robust policies, procedures and risk assessments are in place to ensure the premises are safe and secure, and to support staff's daily practice in protecting children from harm.
- He talks confidently about the activities and learning experiences the setting will provide for children. He understands what is needed to help children enjoy their time at the club and build on the knowledge and skills they are gaining in school.
- The provider has a clear vision for maintaining good standards at the club. He talks confidently about how parents, children and staff will be engaged in the self-evaluation process.
- The provider recognises the need for strong partnerships with the host school. He explains how staff will work closely with class teachers. Two-way communication regarding children's progress and achievements will be shared daily. The provider confirms that staff will provide a range of experiences that complements children's learning in school.
- The provider understands the importance of making sure staff are well supported in their roles. He intends to offer supervision and ensure that staff have regular access to continuing professional development opportunities.
- The provider demonstrates a good understanding of how to promote children's emotional well-being and help them form secure attachments. He explains how staff will work in partnership with parents and class teachers to ensure they have a clear understanding of children's needs.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

- The inspector discussed with the provider the activities he intends to provide for children.
- The inspector looked at policies and documents the provider will use when caring for children and discussed self-evaluation.
- The inspector checked evidence of the suitability of staff members and discussed the support and training available to them.

Goslings Out Of School Club was registered in 2015. The out-of-school club employs two members of childcare staff, both of whom hold appropriate early years qualifications at level 3 or above. The out-of-school club opens from Monday to Wednesday, from 3.20pm to 6pm, term time only.
