Summary of key findings for parents

This provision is outstanding

- The quality of teaching is excellent. All of the adults caring for children work very well together and have extremely high expectations of what children can achieve.
- The childminder precisely monitors children's progress. Parents highly value how she shares this information with them, such as through her online system. The childminder uses this information to plan highly detailed learning opportunities which support children's interests and keep them motivated. Children make excellent progress from their starting points.
- The childminder provides an abundance of inspiring activities, indoors and outdoors, and children can freely access resources to build on and lead their all-round learning.
- The childminder is very enthusiastic and a positive role model for children. She shows genuine warmth and affection for children and they behave remarkably well. The childminder encourages children to be kind and respectful of each other. Children flourish and develop high levels of confidence, self-esteem and independence.
- The childminder is extremely effective at evaluating her practice, and using the wealth of feedback parents provide, to help her provide a high-quality service.
- Partnerships with parents are extremely strong. The childminder engages parents exceptionally well in children's care and learning. For example, she provides monthly newsletters, regular meetings, a parents' board and questionnaires.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

continue to develop on the already excellent opportunities for children to build on their mathematical skills even further.

Inspection activities

- The inspector observed younger children engaged in activities and the childminder's interaction with them.
- The inspector spoke with the childminder and the parents at appropriate times during the inspection.
- The inspector sampled a range of documentation, including children's details, learning records, insurance and other relevant documentation.
- The inspector looked at parts of the house used for childminding purposes.
- The inspector observed children's play with the childminder and discussed children's learning and progress.

Inspection findings

Effectiveness of the leadership and management is outstanding

Safeguarding is effective. The childminder and her co-childminder have an excellent understanding of their role to identify any concerns about a child's welfare and who to report these to. The childminder diligently keeps this knowledge up to date, such as by completing training. She ensures all adults are appropriately vetted and notifies Ofsted of significant events. She monitors her assistant to ensure they understand their role and responsibilities. The childminder supervises children well to help keep them safe. She has excellent links with other providers and professionals; she has been chosen to disseminate her knowledge to support other settings to improve their practice. The childminder places a strong emphasis on professional development. For example, she now uses different techniques to enable parents to fully engage in their children's learning, such as encouraging them to add to their children's learning online.

Quality of teaching, learning and assessment is outstanding

The childminder's sharply focused and high-quality planning assists all children to make exceptional progress. She encourages children's emotional development effectively. For example, younger children confidently separate from their parents on arrival and eagerly engage in pretend play with toys. Older children enjoy the responsibility of carrying out small tasks. The childminder encourages children's physical skills exceptionally well. For example, younger children experiment with different ways of moving and explore linking objects together, such as by pulling, turning and poking operational toys. The childminder supports children to make them think and places a high priority on introducing new vocabulary, concepts and ideas. She develops children's mathematical awareness; however, on occasion, she misses opportunities to extend this area even further.

Personal development, behaviour and welfare are outstanding

The childminder provides children with inspiring experiences to increase their awareness of the wider world. For example, children delight in identifying what is unique about them and experiencing other cultures, such as trips to local churches and mosques. The childminder offers children a rich range of experiences to learn about healthy lifestyles. For example, they are involved in grocery shopping and planning and preparing meals. Children show delight as they select fruits and prepare their own fruit salads.

Outcomes for children are outstanding

Children are extremely well prepared for their next stage of learning, including school. Younger children demonstrate excellent skills when listening to instructions and carrying out increasingly complex tasks. Children thoroughly enjoy the routine and are highly motivated to learn and to try new experiences.
