Summary of key findings for parents

This provision is inadequate

- Leadership of the nursery is weak. The provider does not have the appropriate skills or expertise to monitor and challenge managers effectively.
- The provider has failed to ensure that robust procedures are in place for recruiting and vetting staff. References are not followed up and there is a lack of information to demonstrate staff suitability. Therefore, safeguarding is ineffective.
- The outdoor play area is not a stimulating play environment to support children's learning and development. Resources are sparse, poorly organised and unclean. Indoors, the play equipment is not organised effectively. Resources to support writing and technology are limited, not age appropriate or in working order.
- The provider has failed to ensure that the ground floor bathroom is suitable for use by young children. An absence of heating makes the area extremely cold and the hot water temperature is too hot for children to use safely.
- Leaders and managers do not make appropriate checks on staff's levels of literacy. Writing on notices and display boards is weak with several errors in spelling, punctuation and grammar.
- Partnerships with health visitors and local schools are not well established. This hinders the manager's ability to ensure assessment is as precise as it can be.

It has the following strengths

- Children have good levels of concentration and spend time persevering at tasks.
- Children show kindness towards each other. They join in as a group to help their friends who are not as confident or able as themselves.

What the setting needs to do to improve further

To meet the requirements of the early years foundation stage and the Childcare Register the provider must:

Inspection activities

- Her Majesty's Inspector (HMI) held meetings with the registered provider and manager, and spoke to children, staff and parents at appropriate times during the inspection.
- HMI observed the quality of teaching and its impact on children's learning.
- HMI looked at a range of documentation including information about each child, records of the progress children have made and evidence on the suitability of any person who lives or works on the premises where childcare is provided.
- HMI viewed the rooms and resources used by children.

Inspection findings

Effectiveness of the leadership and management is inadequate

Expectations are not high enough. Although actions from the previous inspection have been addressed, the owner does not have an accurate overview of the quality of the provision. There are further breaches in both the learning and development and safeguarding and welfare requirements. Therefore, the provider has not fulfilled her responsibilities to ensure that all the requirements of the early years foundation stage are met. The current supervision arrangements for the manager lack rigour and do not help the manager to improve her practice. Recruitment and vetting procedures are not robust. The provider has not acted swiftly enough to follow up references from newly appointed staff. In addition, there is a lack of information to show how staff are assessed as suitable for the post to which they have been appointed. Therefore, safeguarding is not effective. Staff are well qualified, training is up-to-date and they work well with parents to support children's learning and development.

Quality of teaching, learning and assessment is inadequate

Staff do not consistently plan exciting activities to help children make the best possible progress. In particular, the outdoor area is poorly organised to support children's learning and development. Water trays are empty, the sand pit is covered, dolls and prams are unclean, the play house is uninviting, the fruit and vegetable stall is empty and resources to support mathematics are out of reach. A small group of girls show great interest as they enthusiastically dig in the soil and explain how they are looking for 'wiggly worms'. Indoors, resources to support writing and technology are limited. Pencil crayons are an inappropriate size for young children and not sharpened sufficiently. Torches and other battery operated toys are too few and not in working order. This means that children's progress slows. The standard of spelling, grammar and punctuation on display boards and notices is poor. Children engage well with staff. They identify various items of fruit and persevere as they attempt to cut large pieces of cucumber.

Personal development, behaviour and welfare are inadequate

The provider has failed to ensure that the ground floor bathroom is fit for purpose. The lack of heating means that the area is extremely cold and unsuitable for use by children. In addition, the hot water is not safely regulated and is too hot for children to wash their hands under. Therefore, children have no option but to wash in cold water. Effective use of newsletters to parents has improved the range of healthy food children bring for lunch. Children enjoy sitting together over lunch time and chatting. This develops their social skills well. Children are confident and very comfortable around staff. They know when to listen, respond to praise well and behaviour is good.

Outcomes for children are inadequate

Outcomes for children are poor. Children's learning is hindered as the curriculum does not provide challenging and enjoyable experiences across the seven areas of learning. Resources are poorly organised making it difficult for children to make choices. Tracking the progress children make is not yet secure and observations to identify best teaching practice is still in the early stages. For those children who need more support their

individual needs are met. Staff know them well and work in partnership with parents, carers and other agencies.

Little Roses Nursery was registered in 2014 and is situated in Oldham. The nursery is open each weekday from 8.45am to 3pm. The nursery employs eight members of childcare staff who all hold appropriate early years qualifications. The nursery opens Monday to Friday, from 8.45am to 3pm and is closed for bank holidays.
