Summary of key findings for parents

This provision is inadequate

- The provider has failed to meet the requirements of the early years foundation stage and the requirements of the Childcare Register. Self-evaluation is weak.
- The provider has not ensured that the manager and staff have the necessary knowledge, qualifications and skills to fulfil their roles effectively.
- Staff induction, support and supervision procedures are ineffective. The provider does not identify weaknesses in staff practice or provide support for them to develop their skills further. Not all the required paperwork was available for inspection.
- The safeguarding policy has not been updated. The provider has not ensured that staff understand the policy and know how to identify concerns about a child's well-being. This includes recognising when a child may be at risk from extremist views. This puts children's welfare at risk.
- The provider has not followed safe recruitment procedures. They do not have systems in place to check staff's ongoing suitability to provide care for children.
- Information relating to children's health has not been shared fully with key staff. As a result, staff are unclear about children's individual needs and how to meet them. Arrangements for the provision of medication are not safe.
- Arrangements to gather information from the school are not in place. This means staff are not providing children with activities to complement their experiences at school.

It has the following strengths

Children are happy and confident. Staff provide activities that engage the children in play. Parents are happy with the care provided.

What the setting needs to do to improve further

The provision is inadequate and Ofsted intends to take enforcement action

- The inspector observed children's activities inside and outside.
- The inspector sampled a range of documents, including children's information records, accident records, recruitment records and evidence of the suitability of staff working with children.

Inspection findings

Effectiveness of the leadership and management is inadequate

The provider has not ensured that the manager has a sufficient understanding of the early years foundation stage. As a result, the manager is unable to identify breaches in the requirements. Safeguarding is ineffective. The provider has failed to update the safeguarding policy, this means staff are unclear about who to contact should they have concerns about a child's welfare. The designated person for safeguarding has a suitable knowledge of child protection procedures, but they have not shared this with the staff team. As a result, not all staff are aware of how to identify when a child may be at risk of harm. Recruitment and vetting procedures are not thorough enough. There is insufficient evidence to demonstrate that all staff working with children are suitable to do so. For example, there is no evidence that references have been obtained for all staff. Staff are unaware of the need to disclose information that may affect their suitability to work with children. Induction and supervision arrangements are not effective and are not ensuring good quality, safe provision for children.

Quality of teaching, learning and assessment requires improvement

The manager does not monitor the quality of staff interactions with children. Some staff supervise and direct rather than supporting children and engaging in their play. Staff have a basic knowledge of children's individual interests and abilities. However, they do not gather information about the children's experiences at school. This means children may not have the opportunity to put into practise new skills they have acquired at school. Children enjoy their time at the club. They spend time talking with their friends and using their imaginations. Staff talk with children about the activities they would like to have in the future. Children are independent and enjoy developing their physical skills outside with scooters and balls.

Personal development, behaviour and welfare are inadequate

Weaknesses in safeguarding mean children's safety and welfare are at risk. The provider has not ensured that a key person has been assigned to meet the needs of children. This means that staff do not have sufficient information about children's individual health needs. As a result, staff are unaware of potential indicators which may mean that children are unwell. Children's individual medication is not readily available to staff. This poses a significant risk to children's health, safety and well-being. Staff from the school bring the children to the club and provide a handover. This means that children feel secure and settle quickly. Children behave well; they know the rules of the club and ensure others follow them. Staff treat children with respect and kindness. They remind children about the importance of being caring to others and how to share.

Funtasia Club is a privately owned setting in Weybridge, Surrey which registered in 2008. It operates from Manby Lodge Infant School. Children have access to the main school hall, one school classroom and toilets. There are several areas available for outdoor play. There are 56 children on roll, of whom 24 are in the early year's age range. The club is open from 7.50am to 8.50am and 3pm to 5.45pm, Monday to Friday, term time only. There are nine members of staff, of whom four currently hold appropriate childcare qualifications.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
