# Summary of key findings for parents

# This provision is inadequate

- The management team fails to identify all weaknesses in safeguarding practices. It does not ensure that staff are deployed effectively to supervise children adequately, or that they complete effective checks of the environment to minimise risks to children's safety. These weaknesses compromise children's welfare and are breaches of the Early Years and Childcare Register requirements.
- The management team does not monitor staff practice to ensure that they implement all nursery policies and procedures effectively.
- Staff miss opportunities to support children to develop a secure knowledge of numbers and counting.
- The management team does not reflect on the quality of the provision effectively enough to ensure that all areas for improvement are identified to benefit children.

# It has the following strengths

- Staff provide a wide range of interesting activities that challenge children well. All children make good progress from their starting points, including children who have special educational needs and those learning English as an additional language.
- Staff support children's physical development well. For example, children have daily opportunities for exercise and they take part in musical movement and outdoor play.

# **Inspection findings**

#### Effectiveness of the leadership and management is inadequate

The arrangements for safeguarding are ineffective. The management team does not reflect on the quality of the provision adequately. Children's safety and well-being are put at risk. For example, the management team ensures that staff remain in ratio but does not monitor staff practice effectively to ensure staff are deployed well to supervise children adequately. The management team does not check that staff complete thorough checks of the environment to ensure children's safety. During the inspection, an incident occurred that compromised the welfare of a child. Swift action was taken by the management team to make the outdoor area safe after the incident. The management team supports staff with their ongoing professional development to benefit children. For example, it provides regular coaching and identifies training to enhance their knowledge and skills. However, the management team does not monitor staff practice adequately to ensure that all policies and procedures are followed. For example, staff fail to get parents to sign records in accordance with the nursery's accident policy to show that they have been notified of any accidents. However, policies in relation to the use of mobile phones and administering medication are implemented effectively. Staff are able to discuss the procedures to follow for child protection concerns. The management team ensures that rigorous recruitment and induction processes are in place to check staff suitability. It shares information with other settings children attend to provide a consistent approach to children's care and learning.

#### Quality of teaching, learning and assessment is good

Staff complete meaningful observations and accurate assessments of children's learning. They plan for any gaps in children's learning quickly. Staff hold regular meetings with parents and share information about children's progress to involve them in their child's learning and to provide a consistent approach. Babies and older children develop an awareness of early technology. They explore a variety of resources, including remote-controlled cars, pop-up electronic toys, torches and computers. Staff support children's communication skills well. For example, they repeat words for children learning English as an additional language and for younger children to hear, and use skilful questions to help older children think. Staff miss some opportunities to introduce numbers and counting into children's play. Children develop their creativity through a range of activities. For example, they enjoy music, craft and imaginative play.

#### Personal development, behaviour and welfare are inadequate

Children's welfare is compromised. Staff are not vigilant in ensuring the environment is suitable, safe and secure. For example, staff did not ensure that deep rain water that had collected in certain areas of the garden was removed before young children were allowed out to play. This put young children at significant risk of harm. Nonetheless, staff support children to learn about keeping themselves safe. For example, staff and children regularly practise evacuation drills. Children develop suitable hygiene practices and enjoy healthy meals. Staff support children to learn about the wider world. For instance, they teach children about different festivals and discuss the different habitats where animals live. Children learn to respect one another and behave well.

### **Outcomes for children are good**

All children make good progress from their starting points. Children gain confidence in their abilities and are inquisitive. They are confident to explore and make independent choices in their play. Children of all ages develop a good awareness of literacy. For example, younger children enjoy looking at books and older children learn letter sounds. Children gain the skills they need for the next stages in their learning and for school.

Busy Bees Day Nursery At Farnborough IQ registered in 2015. The nursery is situated in the grounds of Farnborough Business Park, Surrey. The nursery is one of 237 children's nurseries nationwide owned by Busy Bees Nurseries Ltd. The nursery is in receipt of free early education funding for children aged two, three and four years. The nursery opens from 8am to 6pm on Monday to Friday, all year round. There are 28 employed staff; one of whom holds a level 4 qualification, 17 hold a level 3 qualification and two have a level 2 qualification.
