## Summary of key findings for parents

### The provision does not meet requirements

- The childminder does not have public liability insurance cover in place, which is a breach of the Early Years and the Childcare Register requirements.
- The childminder understands how children develop. She knows how to use observations and assessments to monitor children's progress, and to help her plan suitable activities to support their ongoing learning.
- The childminder understands how to help children learn to behave, and to be kind and considerate to others.
- The childminder has suitable safeguarding knowledge and is confident about the procedures to follow to report any concerns about children's welfare.
- The childminder understands the importance of working in partnership with parents and professionals involved in children's care, to support continuity in their care and learning.
- The childminder understands the importance of evaluating her practice to maintain continuous improvement. She plans to attend training to enhance her skills.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
