# **Summary of key findings for parents**

#### This provision is inadequate

- Young children are not allocated a key person to help them to build relationships and ensure their care is tailored towards their individual needs.
- Staff and the acting manager do not benefit from supervision meetings that provide them with coaching and support as well as opportunities to discuss any issues.
- Children's health and safety is not assured. Not all staff know how to deal with an emergency situation with children who have medical needs or allergies. Additionally, not all staff involved with preparation of food have had training in food hygiene.
- Not all staff have a secure understanding of the reporting procedures if a child is at risk of abuse.
- The provider has not notified Ofsted of changes to management committee members in a timely way. Additionally, they have failed to provide Ofsted with the required information for some of those members to enable suitability checks to be completed.
- Not all required records and documentation were available at the inspection, including details of the Disclosure and Barring Service checks for committee members, and their names, addresses and contact details.
- At times, older children's physical, boisterous play affects younger children's safety and their enjoyment of activities.

#### It has the following strengths

Children benefit from a broad range of resources. They enjoy their time in the club and develop good friendships with each other.

# **Inspection findings**

#### Effectiveness of the leadership and management is inadequate

Safeguarding is ineffective. The management committee does not demonstrate a suitable understanding of legal requirements. Ofsted has not been notified of changes to members of the management committee in a timely way. In two instances, Ofsted has not received committee members' details, including their Disclosure and Barring Service checks, to enable the suitability assessment process to be completed. Staff demonstrate sufficient knowledge of the signs and symptoms of child abuse. However, they do not have a secure understanding of the procedures to follow if they have concerns that a child is at risk. Required documentation is not available. There have been recent changes to the management of the club and some essential systems have lapsed. For example, young children are not allocated a key person to support their welfare and help to develop links with parents. Managers and staff do not have opportunities for supervision meetings with their line managers to discuss any issues they may have, review their suitability and identify professional development needs. Parents speak well of the club and say their children enjoy attending.

#### Quality of teaching, learning and assessment requires improvement

Staff provide a good range of resources for the children and encourage them to make choices. Children become engaged in their self-chosen activities, such as using swing bikes in the school playground. Staff have reasonable links with the school and are aware of the themes and topics children cover in class. This helps them to complement children's learning in the club. Children have a comfortable area to relax. They help themselves to books or watch a suitable film on the television. They negotiate their own sharing as, for example, they write their names on a list to use the computer. Staff support the children as they play, supervising their activities and offering help if needed. Children spend a good deal of time outdoors and clearly enjoy active exercise. However, there are times when older children play boisterous games, such as football, that spill over into the younger children's activities.

#### Personal development, behaviour and welfare are inadequate

Children with medical and special dietary needs are at risk as not all staff are aware of the procedures to follow if children require emergency medication. Care plans for these children are recorded but some staff do not know where these are kept. Absence of a keyperson system means opportunities are lost to strengthen links with children and parents and ensure children have their individual needs met. Nevertheless, children do develop emotional bonds with staff over time. On the whole, they behave well and have affectionate relationships with each other. Children enjoy simple snacks, which they help to prepare for themselves, such as fruit, toast and crumpets. Not all staff have the necessary training to handle food safely. Therefore children's health cannot be assured.

The Meadow Out Of School Club registered in 1997 and is a registered charity managed by a voluntary committee. There are five members of staff who work directly with the children. Of these, four hold appropriate qualifications at level 3. The setting is open Monday to Friday from 7.45am to 9am and from 3.15pm to 6pm, during school term time. A holiday club operates during some school holidays, subject to parental demand. Opening times are 7.45am to 6pm.
