Summary of key findings for parents

The provision meets requirements

- The childminder is aware of the process to follow if she has a concern over a child's welfare. She understands how to keep the premises free from hazards so that children can play safely.
- The childminder knows how to provide a range of toys and activities to engage children in play. She understands how to observe and assess children's development to extend their learning.
- The childminder knows how to encourage positive behaviour from children. She is aware of the need to widen their understanding of differences in society.
- The childminder understands the importance of sharing information with parents and other professionals to help provide consistency for children's learning and care.
- The childminder recognises the need to evaluate her practice and understands how to involve others in the process. She has considered the recommendation from her last inspection to make improvements for children.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector reviewed areas of the premises used for childminding.
- The inspector held discussions with the childminder to assess her knowledge of the statutory requirements.
- The inspector reviewed some of the childminder's policies and documents.
- The inspector discussed the childminder's systems for self-evaluation with her.

The childminder registered in 1993. She lives in the London Borough of Hillingdon. The childminder operates Monday, Tuesday and Thursday throughout the year, between the hours of 7.30am and 6pm. There were no children on roll at the time of this inspection.
