Summary of key findings for parents

This provision is inadequate

- Children's safety is at risk. The provider, who is also the manager, does not ensure that all adults have completed all required suitability checks. Self-evaluation is poor.
- The provider does not ensure that all staff have sufficient knowledge of all safeguarding policies, procedures and latest legislation, or implement them sufficiently to safeguard children. The safeguarding policy is not in line with the local authority procedures.
- The provider does not have effective systems to ensure that there is at least one person who has a current paediatric first-aid qualification on the premises at all times.
- The provider does not ensure that all staff can follow emergency fire evacuations, which puts children at further risk.
- The provider has failed to assign a deputy to fulfil the manager's duties in her absence.
- The provider has not implemented systems to support staff and help them to improve their knowledge, to enable them to implement successful teaching strategies. She has not implemented the key-person system sufficiently to meet children's needs.
- Not all staff understand how to build on children's learning and interests. Staff do not observe, assess and monitor children's progress effectively. The required progress check for children aged between two and three years is not completed or shared with parents. Children's progress is not good enough from their starting points.

The provision is inadequate and Ofsted intends to take enforcement action

Inspection findings

Effectiveness of the leadership and management is inadequate

Safeguarding is ineffective. The provider does not follow robust recruitment procedures to ensure all staff have suitability checks, including obtaining an enhanced Disclosure and Barring Service check and references. The provider and staff do not have a secure understanding of all child protection procedures. In particular, this relates to the procedures to follow if an allegation is made against a member of staff and identifying signs that a child might be at risk of extreme views. The safeguarding policy is not in line with the latest Local Safeguarding Children Board guidance. Moreover, staff do not follow robust procedures to monitor any potential concerns about children to fully safeguard them. The provider has failed to appoint a deputy manager who is capable and able to fulfil the manager's duties in her absence. She does not ensure that at least one manager is available during operational hours at all times. However, she ensures that the ratio requirement is met at all times. The provider does not monitor children's progress to identify and close gaps in their learning. She does not ensure staff complete the required progress check for all children aged between two and three years, or share a written summary of this check with their parents. Parents do not receive information about their children's progress regularly to maintain consistency in children's learning. The provider has addressed previous recommendations, but she has failed to identify and promptly address all breaches in requirements and weaknesses in practice.

Quality of teaching, learning and assessment is inadequate

The provider does not ensure that staff receive enough support and training to teach children adequately overall. Although staff observe children, they do not make good use of this information to identify and build on children's starting points, or the next steps in their learning, and to plan challenging activities that interest children. For example, the youngest children do not have their favourite activities and resources available for them to help them feel settled and build on their interests. Children are not always learning what they need to know next in order to make good progress towards the early learning goals. Staff tend to focus on the monthly theme and are not responsive to individual children's own ideas and ways of learning around the subject. Staff do, however, provide children with some activities that they enjoy. For example, children develop their creativity as they play with play dough, and staff read books to them and engage them in discussions during group times.

Personal development, behaviour and welfare are inadequate

The provider does not support children's welfare adequately. Although there is one member of staff with a current paediatric first-aid qualification, the provider has not considered how she would meet children's needs should this first-aider be absent. Moreover, the provider does not ensure that all staff are familiar with the nursery's emergency evacuation procedures, which puts children's safety at further risk. The key person system is ineffective. Not all parents know their child's key person to maintain a shared approach to children's care and leaning. Moreover, children do not have an assigned key person from the very beginning to help them settle and build relationships with their key person. This affects the youngest children's ability to settle quickly and

smoothly. Children generally behave well. Staff help them understand acceptable behaviour and encourage them to share and take turns. Children follow appropriate hygiene rules. They have opportunities to exercise and learn about healthy lifestyles.

Outcomes for children are inadequate

Outcomes for children are poor. Most children fail to make typical progress based on their starting points. Children are not well prepared for their next stages of learning. They do learn some basic skills, such as independence, following instructions and counting.

Cricket Nursery registered in 1999 and has been under new ownership since 2016. It is located in the London Borough of Harrow. The nursery opens weekdays, from 9am until 3.15pm, during school terms only. The nursery is in receipt of funding to provide free early education for children aged two, three and four years. The provider employs six members of staff, five of whom hold relevant childcare qualifications at level 2 and above.
