# **Summary of key findings for parents**

#### This provision is inadequate

- The provider, who is also the manager, does not meet the Early Years Register and the Childcare Register requirements. She has not understood her responsibility to notify Ofsted of changes to the committee members over the last two years so that the required suitability checks can be completed.
- Staff have not made links with other settings that children attend. They are unaware of what children are learning elsewhere or how their needs are being supported. Outcomes for children vary.
- Children do not have a wide range of opportunities to learn to be independent and complete tasks for themselves. Staff do not consistently plan group activities and some daily routines to fully engage and support all children.
- Self-evaluation is not used effectively to identify breaches in requirements and areas for improvement.

#### It has the following strengths

- Staff build on children's interests to provide resources which engage them in their play and learning.
- Children settle well and are confident to talk to adults and children.

# **Inspection findings**

#### Effectiveness of the leadership and management is inadequate

Safeguarding is ineffective. The provider has not informed Ofsted of any changes to the committee within the required timescales. The entire committee has changed on more than one occasion over the last two years and Ofsted has not been notified at any point. Ofsted has been unable to complete the required checks to verify committee members' suitability. However, committee members have not had unsupervised access to children. Staff understand the possible signs that indicate a child may be at risk of harm and what to do if they have concerns. Staff have opportunities to develop their skills. For example, they receive one-to-one coaching and support. The provider and staff have recently developed interesting sand and mud digging areas outside. However, their self-evaluation is not effective to help identify breaches in requirements.

#### Quality of teaching, learning and assessment requires improvement

Staff have appropriate relationships with parents to help support children's learning. For example, they share information about children's development and invite feedback about what children have been doing at home. However, staff have not taken opportunities to liaise with other settings that children attend. They do not have any information about what children are learning elsewhere to help provide continuity in their care and education. Staff do not effectively organise some routines and group activities to fully engage and support all children's learning. Children become bored and occupy themselves. Overall, staff support children's communication and language skills. For instance, they hold conversations with children to extend and develop their vocabulary. Children's overall progress is monitored to help identify any gaps in their development.

#### Personal development, behaviour and welfare are inadequate

The weaknesses in safeguarding measures have a potentially significant impact on children's welfare. Staff do not make the most of all opportunities to encourage children to be independent. Nonetheless, children make some choices in their play. For instance, those who prefer to play outside enjoy taking resources with them to explore. Staff ensure that all children are included and valued at the setting. For example, children learn about a range of different cultures and respect each other's backgrounds.

#### **Outcomes for children require improvement**

Not all children make consistently good progress in relation to their individual starting points. Children are not fully engaged in their learning to help them achieve well. They have opportunities to develop their literacy skills. For instance, children begin to learn to recognise and write their names.
