# **Summary of key findings for parents**

#### This provision is inadequate

- The provider has failed to address all actions made at the last inspection and has not identified further weaknesses in the nursery.
- The provider does not ensure that staff have a sufficient knowledge of the procedures to safeguard children. They do not know when a child might be at risk of harm and what to do if they have concerns about a child's welfare.
- Staff do not always fully assess how they will keep children safe when taking them on outings. They do not ensure that they have access to a first aid box with appropriate contents at all times.
- The provider does not monitor the quality of teaching well enough. Although she knows that some staff lack knowledge and skills to fully support children's learning, action has not been taken to address this. At times, the quality of teaching is inadequate.
- Staff do not promote older children's learning fully. They do not follow their play choices or capture opportunities to build on what children know and can do.
- The provider does not use self-evaluation to effectively monitor and improve the weaknesses in the setting.

#### It has the following strengths

Younger children form close relationships with staff and are happy at the nursery.

develop better use of ongoing self-evaluation to identify the strengths of the setting and where action for improvement is needed and improve the quality of provision for children.

#### **Inspection activities**

- The inspector observed the quality of teaching and children's learning, both inside and outside.
- The inspector spoke to staff and children at convenient times during the inspection.
- The inspector spoke to a small number of parents during the day and took account of their views.
- The inspector checked evidence of the suitability of the staff team, confirmation of staff training, recruitment procedures, looked at a selection of children's records and discussed safeguarding procedures and the self-evaluation process.
- The inspector carried out two joint observations with the provider.

# **Inspection findings**

#### Effectiveness of the leadership and management is inadequate

Safeguarding is not effective. The provider, who is the manager, has failed to ensure that all nursery staff have a sufficient knowledge of how to keep children safe. Although some staff receive safeguarding training, they are not kept up to date with recent changes to the nursery's policies or procedures. Furthermore, the provider does not check staff's safeguarding knowledge. Staff do not understand their roles and responsibilities to keep children safe, including what actions they would take if they had concerns about a child. This compromises children's welfare. Self-evaluation is ineffective and has not led to sufficient improvements in the nursery. Supervision of staff is poor. Despite the provider identifying weakness in some staff practice, through her daily interactions with them, she has not addressed this. She does not provide staff with effective development opportunities, such as training or coaching, to raise the quality of teaching to a good level. This does not ensure that outcomes for children are good.

#### Quality of teaching, learning and assessment is inadequate

The quality of teaching for older children is inadequate and does not help to ensure they make sufficient progress in their learning and development. Staff do not follow children's interests, or use activities that children independently choose from, to help them build on what they know and can do. Some staff engage well with children to promote their language and conversation. However, other staff look on at supervised activities rather than extending children's learning. The lack of staff interaction with children leaves them frustrated during activities. For example, when a group of children sit at the computer, staff ignore them and don't show them how to switch it on or teach them how to use it. Consequently, children became bored and disinterested in their learning. Staff complete regular observation and assessments of children's progress to plan for their next steps in learning. They share this with parents to form links between home and the nursery.

#### Personal development, behaviour and welfare are inadequate

The provider does not do enough to promote the physical well-being of children. Staff do not have a sufficient knowledge of the nursery's safeguarding policies and procedures. The provider does check the quality of the provision to some extent, including the safety of the premises. However, she does not ensure that staff follow robust risk assessments, particularly when taking children on outings. For instance, staff fail to identify that the first aid kit, which is used in the nursery and when taking children to the local park, does not have the appropriate content. Children learn about some routines that promote their physical health and staff provide emotional support for younger children.

### **Outcomes for children are inadequate**

Not all groups of children are making enough progress, particularly, older and more able children. Younger children, including those for whom the provider receives additional funding, benefit from some experiences. They enjoy learning about colours and make steady progress in readiness for their future learning. Older children gain some independence skills, such as learning how to put on their coats and shoes when going outside.

Treasure (Johanna) Montessori Nursery Pre-School is privately owned and registered in 2011. The provision is open each weekday from 7.30am to 6pm all year round, except for bank holidays. The nursery receives of funding for the provision of free early education for children aged two, three and four years. The owner is qualified and works as the manager. There are currently eight members of staff employed. Six members of staff hold appropriate qualifications at level two or above and of these one holds a level 6 qualification.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register.
