Summary of key findings for parents

The provision meets requirements

- The childminder's home is clean and suitable. The childminder understands the importance of children accessing fresh air and has a safe and well-maintained garden.
- The childminder understands how children learn and develop. She knows how to assess and track their development. She has a variety of appropriate toys and resources available to support and build on children's learning.
- The childminder is confident in the procedures to follow to protect children's welfare. She has suitable safeguarding procedures and understands the referral system.
- The childminder understands the importance of good partnerships with parents. She has required documentation in place to maintain continuity in children's care and learning.
- The childminder understands the significance of keeping her knowledge and training up to date, to maintain requirements.
- The childminder has successfully addressed the previous recommendations made at the last inspection, which shows a commitment to driving improvements.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
