## Summary of key findings for parents

### The provision meets requirements

- The provider is clear in her understanding of how to protect children. All staff complete safeguarding training which prepares them to identify symptoms that cause concern and they know what action to take if they have any worries.
- The provider recognises how good information sharing with parents and the school helps her to build strong and positive partnerships and ensures consistency of care.
- The provider understands the importance of providing children with a range of stimulating activities to reflect their individual interests and challenge their abilities.
- The provider knows how to promote children's good health. She understands the importance of staff acting as suitable role models to promote children's good behaviour and respect and to help them develop caring, responsible attitudes.
- The provider understands how deploying staff effectively, carrying out consistent risk assessments and having efficient reporting systems, helps to ensure children's safety.
- The provider understands how evaluating her provision and including the views of children and parents help to drive continuous improvement and improve outcomes.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Pixies Kidz Clubz (Pickhurst) registered in 2005. The club operates from the junior premises of Pickhurst Primary School, West Wickham in the London Borough of Bromley. All of the children who attend the group are pupils of Pickhurst Junior School. The after-school club opens five days a week during the school term, from 3.15pm until 6.00pm and the breakfast club operates from 7.50am until 8.50am. A team of five staff, including the manager, works directly with the children. Of these, four members of staff hold relevant qualifications.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
