Summary of key findings for parents

This provision is good

- Leaders are passionate and have high aspirations for success. They are highly reflective and have used accurate evaluations to implement successful changes to their setting since their last inspection. This has enhanced the experiences for children who attend.
- Children make good progress from their starting points and staff know children well. Children develop a thirst for learning and exploration and are well prepared for their move to school or pre-school.
- Staff are excellent role models for children. Children behave in a mature and caring manner towards peers and familiar adults.
- Partnerships with parents are excellent and staff collaborate remarkably well with families and other professionals to provide consistency in children's learning and care.
- Staff skilfully engage with children and plan a broad range of activities to develop their skills and interests. For example, staff support children's imaginary play as they pretend to make food in the home corner. They develop children's understanding of the wider world and encourage children to talk about their experiences of cooking at home.

It is not yet outstanding because:

- At times, the organisation of whole group activities does not fully support all children to maintain their focus and attention.
- On occasion, staff miss opportunities to enhance further older children's literacy skills and interest in early writing.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- review the organisation of whole group sessions to help all children develop their focus and attention and gain the most from adult-led activities
- provide even more opportunities to help older children to develop their early writing skills further in preparation for their move to school.

Inspection activities

- The inspector observed teaching and learning inside and outside.
- The inspector spoke to parents to gain their views and experiences of the setting.
- The inspector spoke with children and staff at appropriate times during the inspection and held a meeting with the provider.
- The inspector carried out a joint observation with the manager.
- The inspector looked at a sample of the children's learning records, staff observations, planning and a range of policies and documentation. This included suitability of staff and safeguarding procedures.

Inspection findings

Effectiveness of the leadership and management is good

Leadership is exceptionally strong. Leaders support their experienced and committed staff team remarkably well and make sure all staff have regular access to professional development to enhance their skills and interests. For example, staff have attended training on natural outdoor play which inspired them to re-design the garden area. Safeguarding is effective. Leaders and staff have a confident knowledge of child protection issues and implement rigorous procedures to keep children safe. Robust vetting and recruitment procedures ensure staff are suitable to work with children. Leaders have excellent arrangements in place to monitor the overall progress that children make. Assessments are shared regularly with parents and other professionals.

Quality of teaching, learning and assessment is good

Staff are enthusiastic and encourage children's spontaneous ideas. Staff support children to develop their thinking skills and problem-solving abilities very well. For example, during a creative construction project outside, staff use skilful questioning to extend children's play and help them think through their designs. Staff make detailed reflections of children's achievements and use this information to plan carefully for their next step in learning. Staff provide a range of first-hand experiences for children to develop their understanding of the world. For example, children enjoy planting sunflowers outside and talk about the life cycles of the real caterpillars they are growing in the classroom. Staff help children to develop their large muscle control, balance and coordination well.

Personal development, behaviour and welfare are outstanding

Children thrive in the sensitive care of the warm and nurturing staff team. Children feel safe and secure and seek to do things for themselves, knowing their key person is close by for support if needed. Staff encourage children to be highly independent. For example, staff make the most of daily routines to develop children's self-care skills. Staff help children to understand the importance of living a healthy lifestyle. The environment is safe and welcoming and staff teach children how to identify possible dangers. Staff build an excellent link between children's home life and the nursery. For example, they plan a variety of family days and children talk excitedly as they remember when their parents came into nursery to help and share books.

Outcomes for children are good

Children are confident and develop strong communication skills. They hold complex conversations with their peers during their play. Children develop a kind attitude towards living things and enjoy taking care of wildlife. Older children gain an understanding of early mathematics. For example, children add together quantities during counting rhymes. Children make good progress and are well prepared for future learning.

Leapfrog Compton Road registered in 2003. The nursery operates in the London Borough of Enfield. The nursery is open every weekday during term time from 9am until 3pm. The provider employs seven staff, five of whom hold relevant early years qualifications at level 3 or above.
